Transportation Planning update	<ul style="list-style-type: none"> John highlighted the key themes/ideas relayed by urban planner Brent Toderian and public transit expert Jarrett Walker at the Mayor’s Inspire series held November 14. Overall, the event was well attended. ITAC members did a great job engaging participants in conversation about transportation in Burlington during the hour leading up to the presentation.

Staff is discussing ridership vs. coverage at this time and working with a consultant on the plan. Other Business	<ul style="list-style-type: none"> The Big Move - a bold and visionary plan that outlines a common vision for transportation for one of the largest and fastest-growing urban regions in North America. The plan introduces a new way of moving around the region. This initiative is led by Metrolinx and they are looking for feedback from stakeholders. Members discussed whether or not they should be reviewing the ‘papers’ and providing feedback? Kaylan indicated that staff will attempt to review the ‘papers’ and provide comments. Staff will look to ITAC for their comments and input on the Directions and Vision in 2017 when a comprehensive report to include transit and planning is presented to council. • Al attended the Burlington City Wide Parking Stakeholders meeting and provided members with a summary of the discussion.
