Subject: Application for re-zoning at 33 Fairwood Place West

Hi Lauren,

We are writing to express our concern about the proposed development at 33 Fairwood Place West. We are the neighbours at 27 Fairwood (directly to the east of the lot).

The application requests new zoning to allow for the owner to squeeze 3 houses on the lot when 2 homes would be appropriate for the current neighbourhood zoning. Not only would it be appropriate for the zoning, 2 detached homes would maintain the consistency, character and quality of the neighbourhood. We realize there are townhomes immediately to the west of this lot, but this makes some sense given that they are across from Aldershot School and Pool. This lot, however is directly across from another detached home with a 60 ft lot.

When you decide to buy a home in Aldershot you do so because you want to live in an area with larger lots and mature trees. If you want a detached house on a 40ft lot with no trees you buy in Alton Village or The Orchard. Having a home lying so much closer to the lot line than is granted by the current zoning will squeeze us and make us feel like we are in one of these neighbourhoods we specifically avoided (not to mention reduce the value of our home).

And finally, the proposal to remove 16 of the 18 trees on the lot is extremely disturbing. Again, trees are a huge part of the value of Aldershot. Many of the trees they want to pull out are on the lot line with our home, or extremely close to it. They are hugely important for privacy, atmosphere and obviously environmental/health considerations. Beyond that, they add value! As I said, people buy in this neighbourhood for trees. As a realtor, and someone who picked Aldershot for my home, I know this to be true. And you can't just replant a 30 year old tree. The "need" to remove them comes from intensifying the lot with 3 homes instead of 2 (where they could retain current set backs). I can't state clearly enough how strongly we feel about the trees.

If this application is granted it sets a precedent for further severing and rezoning applications on our street. Again, this is concerning because we selected a mature neighbourhood to avoid the density and claustrophobia of an Alton Village or Orchard and to get the mature trees that are truly priceless.

This rezoning application is not consistent with the current makeup of the neighborhood where lots that are typically greater than 55 feet wide. In addition, Fairwood Place is already a congested street due to the high penetration of row housing and the Aldershot school. More housing will only exhasberate the problem. Furthermore, the unnecessary removal of trees erodes the beautiful landscape that Aldershot is known for and why I moved into this area.

While I respect the builders intention to sever the land three lots seems quite aggressive. It's more appropriate and consistent with other lots in the neighborhood to sever the land into two building lots.

Please keep me informed as to when I can raise my concerns with city council.

I have recently received an Information Bulletin from The City of Burlington, regarding the Development Proposal for the property at 33 Fairwood Place West.

This opposition is presented on behalf of many homeowners who have invested significant funds & resources to develop & upkeep the area referenced as an 'easement' on the Western side of the designated lots.

The owner/developer had left this area in neglect for many years, including risk from falling branches, a fence in disrepair with a total mud/weed patch instead of any kind of grass or ground cover.

The designated area has been developed & maintained for several years.

It appears that the proposed development requires removal of the fence, removal of a row of mature trees with destruction of the established garden areas. Any new development would reduce/remove the privacy to homeowners from removal of the mature trees & privacy fence, as well as destruction of the established garden areas.
