

Petition

This petition is for the matter of the Oval Court employment land conversion, which will go before Burlington Planning and Development Committee on Tuesday February 27th, 2018 at 1:30PM.

By signing this petition, I hereby affirm that:

- I am a resident that lives in the vicinity of the Oval Court Lands
- It is my opinion that the current employment uses and the overall employment designation of the Oval Court Lands is incompatible with the residential uses south of Fairview Street.
- If this area were to redevelop in the future, it would make more sense to develop it into an area with a mix of uses, such as employment, commercial and residential uses. This would create a more well balanced community along Fairview Street and would be a good buffer from the heavier industrial uses to the north of the railway track.
- I am in support of a motion to re-designate the Oval Court Lands from employment to non-employment, in effect allowing a mix of uses in the area, rather than only allowing incompatible employment uses.
