## **Policy Statement:**

The purpose of this policy is to establish practices related to the placement of temporary roadside memorials.

## Scope:

This policy applies to all roadside memorials which have been placed within the City of Burlington's right-of-way.

## **Objectives:**

The practice of placing memorials at locations where fatal collisions have occurred has become commonplace. This policy outlines the steps that the City will follow to ensure a sensitive and consistent approach is taken in dealing with temporary roadside memorials, while also ensuring the safety of the travelling public, and the interests of adjacent property owners.

#### The policy establishes:

- 1. The period of time a roadside memorial will be allowed to remain in place;
- 2. The allowable dimensions, materials, and location of the memorial;

- 3. Procedures to handle the relocation or removal of a roadside memorial when necessary; and
- 4. Other options for memorials provided by the City of Burlington

### **Procedural Guidelines**

The Roads, Parks & Forestry Department will track and monitor memorials as they appear and/or as the City is made aware of them.

Enquiries from the public prior to the erection of a memorial are to be directed to Roads, Parks & Forestry customer service and forwarded to the appropriate supervisor. The supervisor will provide guidance on this policy to those seeking to erect a memorial.

City staff will monitor existing memorials to ensure they are not a distraction or hazard; do not impede the safe and efficient movement of vehicular or pedestrian traffic; do not interfere with road maintenance or clearance operations; do not impede the use of essential apparatus such as fire hydrants; and do not obstruct access to underground infrastructure.

#### **Conditions**

To minimize any distraction or hazard that any temporary memorial may cause, they may not be located on the travelled portion of the roadway, medians, traffic islands, sidewalks, bicycle paths, or multi-use trails. Items are not to be attached to any traffic signs or other infrastructure.

Persons placing the memorial shall be respectful of adjacent property owners and/or commercial businesses. They must ensure there is no permanent damage and/or alterations to site conditions. To further minimize distractions, the memorial shall not be larger than 60cm (2 feet) high, 60cm (2 feet) wide, and 60cm (2 feet) deep.

All objects placed at the temporary memorial that can shatter (i.e., glass) or have any form of illumination (i.e., candles, solar lights, reflective devices) are not permitted and will be removed by City staff for the safety of the public.

Individuals who gather at a memorial site must do so in compliance with the Highway Traffic Act by conducting themselves in an orderly and lawful manner so not to disturb the peace and privacy of adjacent owners.

# **Corporate Policy**

## Conditions for the removal/relocation of temporary memorial

- Expiration of the twelve (12) month memorial period, from the date of the fatality;
- 2. Creates a safety hazard to the public as determined by the Manager of Road Operations (or designate);
- 3. Interferes with road/sidewalk/traffic maintenance operations;
- 4. Obstructs access to underground infrastructure;
- 5. Complaints from adjacent property owners and/or businesses;
- 6. Temporary memorial has deteriorated into a state of disrepair.

The City reserves the right to remove all materials affiliated with the temporary memorial if required. Roads, Parks & Forestry Department will take all reasonable measures to contact the family to offer assistance to remove and/or collect materials at the memorial. Items will be kept for a period of thirty (30) days at the Operations Centre, after which time they will be disposed if they have not been collected.

The City will work with the Major Collision Bureau of the Halton Regional Police for assistance in situations where it is necessary to contact the owner.

## **Other Memorial Options**

The City of Burlington has a celebration program whereby a park bench or amenity can be donated with a plaque to honour an individual.
