Recommendation:

Approve the amendment to Traffic By-Law 86-2007 as noted in Appendix A to transportation department report TS-17-18.

Purpose:

Installation of warranted 40km/h speed limits as per the Council approved Speed Limit Policy and by-law amendments for the flashing 40km/h school zone speed limits.

Background and Discussion:

40 km/h speed limit requests

Staff has reviewed 11 streets at the request of residents to determine if a reduced 40km/h speed limit is warranted. Staff also reviewed additional roadways near any warranted 40km/h street to ensure a consistent speed limit is in place for the neighbourhood.

To determine the appropriate speed limit for a roadway, staff utilize the Transportation Association of Canada's Speed Limit Guidelines Calculation Sheet as part of the revised Speed Limit Policy, adopted by Council in 2012. Through this review staff has determined that the roadways outlined in Appendix A meet the Speed Limit Policy criteria to implement a reduced speed limit:

New Street Flashing 40km/h School Zone

Staff has determined that the New Street flashing 40km/h school zone from Timber Lane to Meadowhill Road needs to be extended to the east. This will increase safety by reducing vehicle speeds before Meadowhill Road and will ensure a police officer can see the back side flashing beacon for enforcement purposes. The required changes to this flashing 40km/h school zone will be reflected in the amending by-law presented to Council for approval.

Financial Matters:

The estimated cost to install the necessary speed limit signage is \$ 4,000.00.

Source of Funding

The proposed works are to be funded through Capital Order TC0037.

Public Engagement Matters:

All residents on each roadway will be notified of the warranted 40km/h speed limit and anticipated installation date.

Conclusion:

Based on the Council approved Speed Limit Policy, a speed limit reduction is warranted for the roadways outlined within Appendix A. These speed limit changes will result in speed limits that better match the expectation of road users, provide consistency in the application of speed limits and are compatible with the physical characteristics of the roadway and road classification.

Staff has also determined that the New Street flashing 40km/h school zone between Timber Lane and Wedgwood Drive needs to be extended to the east and the required amendment to Traffic By-Law 86-2007, Schedule 13 is outlined in Appendix A.
