### **Community Engagement Activities**

1. Tuck Creek Flood Mitigation EA (Rexway Drive and Rockwood Drive)  
Public consultation has included written, newspaper and website notifications to residents.
  - October 11, 2017 at the Seniors' Centre
2. The Roseland Creek Culvert Upgrade Municipal Class EA project.
  - Public Meeting held on October 6, 2016.
3. Staff provided a presentation on "Responsible Stormwater Management" for a Ward 1 meeting.
  - April 19, 2017 at East Plains United Church
4. City staff and Conservation Halton (CH) staff worked together in presenting a "Healthy Neighboursheds Burlington" workshops on:

These workshops provide an overview of Conservation Halton's operations, City stormwater management systems and Low Impact Development concepts. Guidance from experts is provided, presenting steps to create landscape and gardening plans that are low cost and environmentally friendly.

5. International Council for Local Environmental Initiatives (ICLEI)  
Since the fall of 2016, staff have been participating in the "Great Lakes Climate Change Adaptation Project". This purpose of this project/partnership is:
  - To build capacity for integrating adaptation across the municipality and wider community;
  - To carry out local vulnerability and risk assessments with internal and external stakeholders;
  - To create a network of adaptive communities located within the Great Lakes.

Project #1 – Climate Change Vulnerability and Risk Assessment Workshops

- Workshops held on March 8 and 29, hosted by Capital Works staff.

- Stakeholders included municipalities, Conservation Halton, utilities, community groups, environmental associations.

Project #2 – Climate Change Vulnerability and Risk Assessment Workshop at J. Hayden Secondary School

- Held on April 19, 2017
- Capital Works staff conducted condensed versions of the Vulnerability and Risk Assessment workshops to two Grade 9 geography classes at Frank J. Hayden High School in Burlington. Approximately thirty students in each class participated in the workshop. A brief (twenty minute) PowerPoint presentation provided an overview of the workshop objectives, how Burlington's climate is anticipated to change, and an introduction to adaptation and mitigation, with respect to vulnerability and risk assessment.

Project #3 - Rain Garden construction at Bruce T. Lindley Public School

- Capital Works staff, in partnership with Green Venture (a local environmental education not-for-profit organization), designed and constructed a rain garden on the school property. A Climate Change Adaptation educational program was provided for the students.
