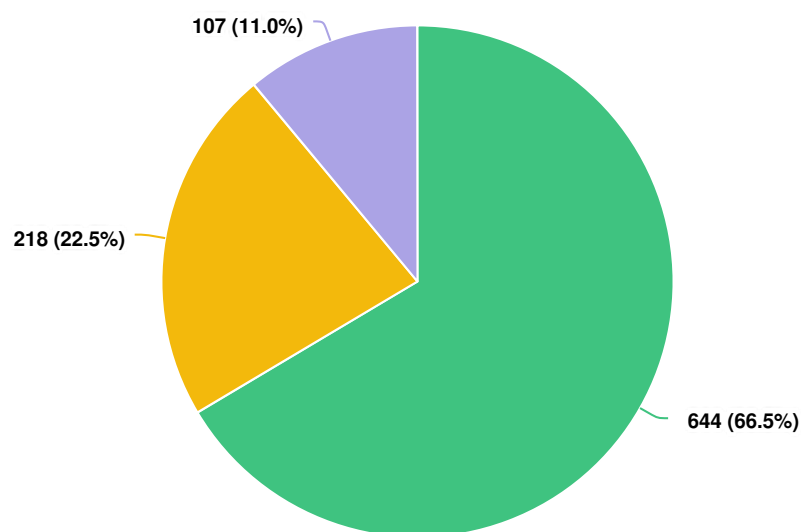

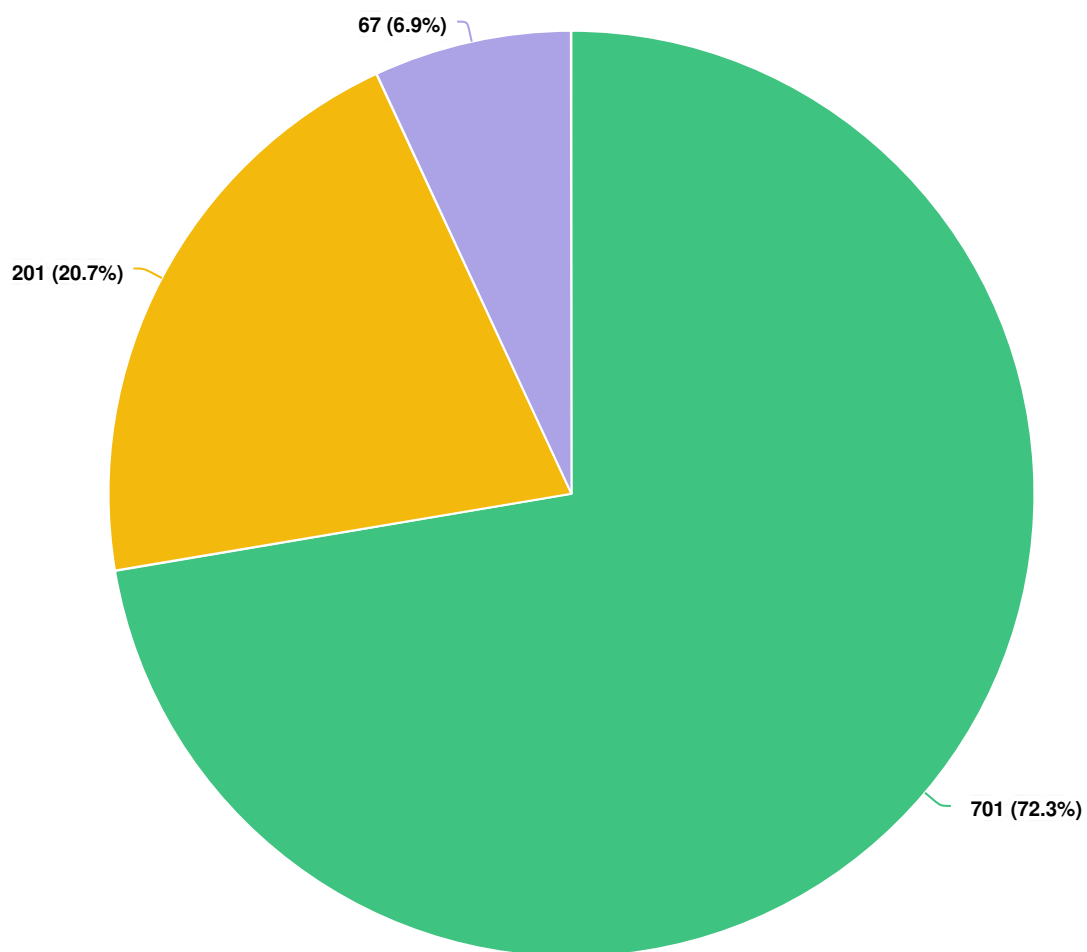


Should municipalities be able to decide / govern the sale and consumption of cannabis in cafes and lounges?
