Community Services Committee on the proposed budget
for the City of Burlington's Integrated Mobility Plan
Burlington for Accessible Sustainable Transit (BFAST)**

April, 2020

The budget recommendation from the Environment, Infrastructure and Community Services Committee for the Integrated Mobility Program is an important milestone in the development of a crucial policy framework that can guide Burlington to a carbon-neutral future. We applaud the efforts of City staff in engaging with community stakeholders and producing a Request for Proposal that reflects a broad consensus that will guide the efforts of its consultants. We congratulate the City in choosing Dillon Consulting, a company with experience in dealing with Burlington's transportation issues, as the successful bidder.

While we strongly support the goals of the IMP and the plans for its development, we believe a key element has not been included in the Plan's budget: the need for a study on the economic benefits of transit. A number of studies have already been done on the benefits of transit to communities and the results are unequivocal: investment in transit is one of the most productive ways a municipality can spend money. Each dollar invested, studies have shown, will bring a significant return on investment through savings on infrastructure spending, increased household budgets spent locally, environmental benefits and other factors. Because these benefits have been shown to be so large, we believe it is important that such a study of this nature be done, for the benefit of both the IMP and the City's Climate Action Plan.

There are two other compelling reasons to fund a study on the economic benefits of transit:

- A renowned economist, whose firm is located here in Burlington, has already completed such studies for nine other communities in Ontario, including our neighbouring city of Hamilton.
- The economist has already developed a methodology, allowing for significant cost efficiencies. We have been informed that the cost for a Burlington study would be a small fraction of the budget the Environment Committee is considering today.

BFAST COMMENTS ON PROPOSED IMP BUDGET

We emphasize that we are not criticizing the budget that has been presented to the Committee. We believe that a small addition to the budget would add a critical source of new information that would greatly assist Council in making a final determination on both the IMP and the actions that will flow from its implementation.
