Motion:

Support the application of Backed By Bees honey winery for a Manufacturer's Limited Liquor Sales Licence for By the Glass.

Background and Discussion:

City staff and BEDC have been working closely with Backed by Bees for the past year and a half to support them in establishing an on-farm market and meadery, with a vision of providing sustainably sourced local food and drink and connecting people to the land. Backed by Bees has obtained all of the necessary planning approvals (i.e. Niagara Escarpment Development Permit and City Zoning Clearance Certificate) and staff are strongly supportive of this excellent opportunity for on-farm diversification and rural economic development.
