PURPOSE:

The purpose of this report is to seek approval to sign and endorse the Halton Equity and Diversity Roundtable (HEDR) Charter of Halton.

Vision to Focus Alignment:

• Building more citizen engagement, community health and culture

Background and Discussion:

The Halton Equity and Diversity Roundtable (HEDR) is a Halton wide organization that works with, "organizations, institution, groups, businesses and individual community that is committed to building systemic inclusions and equity in Halton." (HEDR website)

Their mission is:

"To develop the capacity of human service organizations to advance equity and inclusion in Halton through knowledge, skill and relationship building."

Their vision is:

"An inclusive community where individuals are valued, respected and empowered."

One of the key action items from HEDR is to provide resources, education, training and advocacy for organizations to be more inclusive and equitable in their practices, policies and services. One of the first steps to starting the conversation and building awareness is asking people and organizations to endorse their charter, see appendix A. Through the Halton Regions Community Safety and Wellbeing System Leadership Team Group meeting on September 22, 2020, all organizations of the System Leadership Team, including, the three of the four school boards, Halton Regional Police, Halton Region, the local hospital groups, and the four municipalities of Halton, were asked to endorse the charter. This report is seeking Council's approval to sign and endorse the charter on behalf of the Corporation of the City of Burlington.
