


R.C.G.A. RULES GOVERN ALL PLAY EXCEPT AS MODIFIED BY THE FOLLOWING:

## Golf Courses Replaced by Housing

The most recent statistics from Golf Canada, the sport's national governing body, show 51 courses shut down between 2015 and 2018, including 19 closures in Ontario. In the same period, 22 new courses were either launched or under construction. In other words, two clubs are closing for every new track that opens.

"Golf has never been in a healthier place in Canada," in terms of the number of players and their engagement in the game, said Laurence Applebaum, chief executive officer of Golf Canada. "But there are two sides to the coin. Golf courses have become part of the story of a robust real estate market, particularly in the greater Toronto region."

The SCA has retained the services of a municipal, land use planning and environmental lawyer, Kristi M Ross, to finalize the Tripartite agreement between the SCA, Mattamy Homes and the City of Ottawa, as well as the Purchase & Sale agreement for the golf course lands. The first copies of these agreements have been drafted by Mattamy Homes and Kristi Ross is now in the process of reviewing them in detail to ensure they adhere to Mattamy's Letter of Intent (LOI). The City of Ottawa's legal team has also received these agreements and must review them as well. The Purchase and Sale agreement is required by the City of Ottawa's Finance and Economic Committee (FEDCO) before the levy can be incorporated into the 2021 Property Tax Roll.


CBC - Ottawa City aces legal dispute over Kanata golf club Social Sharing An Ontario court judge has upheld a 40-year-old agreement that says the Kanata Lakes Golf and Country Club must remain open space and not be redeveloped into a housing community.

The decision is a big win for the city, Kanata North Coun. Jenna Sudds and her constituents, who have spent two years trying to prevent property owner ClubLink from turning the course into a 1,500-home development with its partners Minto Communities and Richcraft Homes.

Sudds, who said she burst into tears over Friday's decision, called it "terrific news" for the community. As many as 500 homes back onto the course and more than 1,000 households use the grounds for recreation, she said. "The green space, the golf course itself, which really is right in the middle of our community here, is used by the community quite frequently," said Sudds, who recently moved to the neighbourhood. "I see people out all hours of the day throughout the winter. It's amazing to see all the tracks snowshoeing and skiing and dog-walking."

#### 2.6 ROLE OF COUNCIL

It is the role of Council:

- a) To represent the public and to consider the well being and interests of the municipality.
- b) To develop and evaluate the policies and programs of the municipality.
- c) To determine which services the municipality provides.
- d) To ensure that administrative policies, practices and procedures and

controllership policies, practices and procedures are in place to implement

the decisions of Council.

e) To ensure the accountability and transparency of the operations of the

municipality, including the activities of the senior management of the

municipality.

- f) To maintain the financial integrity of the municipality.
- g) To carry out the duties of Council under the Municipal Act, 2001 S.O. 2001,
- c. 25 or any other Act.
