9.2 Council and staff updates

a. Councillor Sharman

Councillor Sharman provided the following updates:

- There are two strategies coming to council in the near future, the Parks and open spaces strategy and a housing strategy. There will be opportunity for the committee, and the general public to provide comments and feedback.
- There are (at the time of this meeting) 48 appeals of the Official Plan. Link to list of appeals on the City website <u>Appeals to the</u> <u>Official Plan</u>
- The Housing Strategy will be very challenging, there is an issue with affordable housing in Burlington. Where are the aging population going to live when they are ready to see their family homes? The committee discussed the issues facing affordable housing in Burlington and how infill development impacts greenspace available as part of development.
- b. Lynn Robichaud Sustainability

Lynn provided the following updates:

- happy to announce that the City has hired a new staff person to fill the Energy and Emissions Analyst position and will start her role on Feb. 1
- Staff will be reviewing several corporate polices including the zero waste policy, corporate energy policy and sustainable buildings. When appropriate these will be brought to the committee for comment and feedback.

Laura provided the following updates:

- the Climate Adaptation Plan is being headed up by Fleur with a report going to committee in March, the report will highlight what climate impacts we can expect from 2025 - 2050 adn 2050 -2080
