City of Burlington By-law XX-2021

A By-law to amend the Rates and Fees By-law 92-2020, being a by-law to establish and impose certain 2021 rates and fees for services, activities or the use of property File: 110-04-1 (RPF-05-20)

Whereas sections 8, 9 and 11 of the *Municipal Act, 2001*, authorize the City of Burlington to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the City of Burlington; and

Whereas subsection 391(1) of the *Municipal Act, 2001*, provides that section 9 and 11 of the Act authorize the City of Burlington to impose fees or charges on persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control; and

Whereas the Council of the City of Burlington authorized the passage of By-law 92-2020 for the purpose of establishing the list of 2021 fees and charges;

Whereas Council deems it appropriate to amend the Rates and Fees By-law 92-2020 to impose and amend certain trees applicable to The City of Burlington Private Trees By-law;

Now therefore the Council of The Corporation of the City of Burlington enacts as follows:

- 1. That Schedule A, page 35 of the Rates and Fees By-law 92-2020 titled "Service: Tree Management" be removed and replaced in its entirety with a new page 35 titled "Service: Tree Management" in the form appended here as Appendix "A" and forming part of this By-law.
- 2. That in all other aspects, By-law 92-2020 be and is hereby confirmed.
- 3. This By-law comes into force on the date of its passing.
