

## Burlington Deep Energy Retrofit Program –

transforming existing buildings

- Partnership with Centre for Climate Change Management @ Mohawk College
- Application for funding FCM's Community Efficiency Fund
- Stakeholder engagement interim report
- Next: homeowner survey & assess financing options
- Federal budget \$4.4 billion to support home energy efficiency loans
- Final report prior to year end 2021





## Electric Mobility & Equipment –

encouraging the adoption of electric mobility & equipment

- Electrification of transportation sector to meet 2050 net carbon neutral target
- 23 charging stations on city property (44 charging heads)
- Corporate policy to be developed
- Develop Electric Mobility Strategy & e-bikes
- Funding options

# **Renewable Energy** – stimulating local renewable energy projects

- Over 8 MW of renewable energy in Burlington
- Renewable energy cooperative model
- Ground source heat pumps (geothermal)
- Other municipal programs Edmonton & Halifax
- Google Environmental Insights Explorer
- More research needed in this area

- IMP under development by Transportation Services
- Vision Mobility in Burlington will be safe, accessible, sustainable, balanced & livable
- Burlington Cycling Plan council endorsed March 2021
- IMP network designs will be presented to public July 2021






### Greenhouse Gas Emissions by Year – with 2050 Target






### Annual Emissions by Source 2011 - 2020
