Recommendation:

Authorize the Director of Recreation, Community and Culture to approve adjustments to 2021 Rates & Fees for school board amenities and gyms as set out in recreation, community and culture department report RCC-07-21 in accordance with its authority under section 7 of Rates and Fees By-law 92-2020.

PURPOSE:

Background and Discussion:

Strategy/process

The City of Burlington and the District School Boards have a long-standing tradition of cooperation and agreements/arrangements that fall under the Reciprocal Agreement for the shared use of athletic space, facilities, and amenities, primarily on an in-kind basis. The goal is to have any rate changes match and be consistent with the agreement, which stipulates that neither side can profit from the arrangements.

The School Board determines the rate increase annually. Originally set to increase at 2% effective Sep 2021, the school board later determined and recently shared the 2021 rates for school amenities and gyms will have a 0% rate increase.

The Rates & Fees are established based on the By-Law 92-2020, a by-law set to establish and impose certain 2021 rates & fees for services, activities or for the use of property.

Options Considered

No alternative options exist as this an administrative amendment to the Rates and Fees document.
