While it is entirely reasonable to allocate new density to transit corridors like Plains Rd, the incentives of development must be balanced against the long-term interests of the community itself. The six-storey zoning for this site already establishes a significant change to the existing fabric of one and two-storey buildings. For example, 18 Plains Rd W and 34 Plains Rd E follow the six-storey rule. It is not difficult to imagine a future in which many sites along Plains are built to this same height limit, and while that image is very different from the Aldershot of old, it seems to satisfy a relatively balanced approach to intensification. 40-70 Plains Rd E should follow suit. Urbanistically, there is no reason to grant this developer significant exemption from height and density rules.
