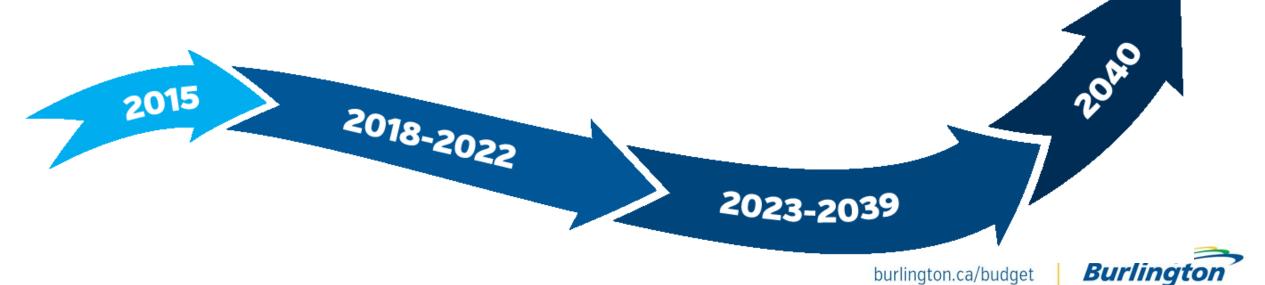

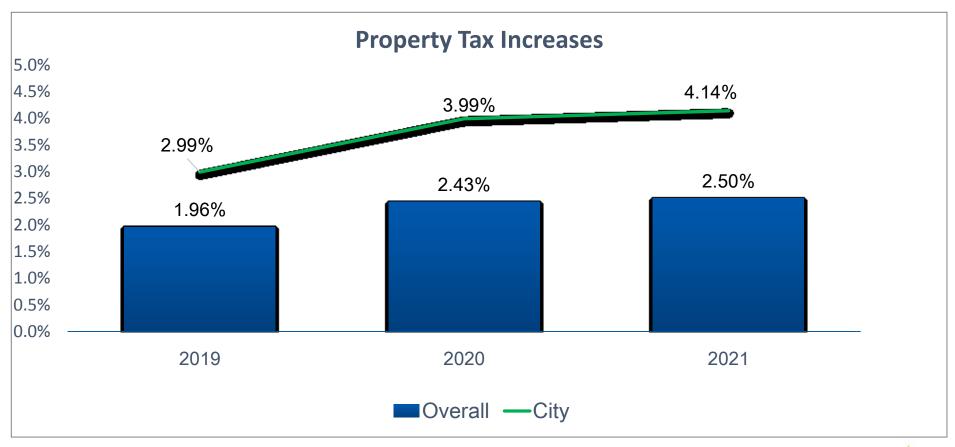

### Investments – Sustaining City Services

### Staffing Investments

- Arena / Pool Operator Conversions to FT (0.9 FTE)
- Winter maintenance staffing conversion (1.4 FTE)
- 3 Heavy Equipment Operators
- 2 Gardener / Landscapers for Downtown
- 3 Arborists and new equipment
- 2 By-law Enforcement Officers





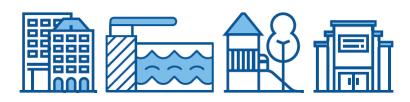


### **Operational Investments**

- \$100K increased investment in recreation facility maintenance
- \$67K increase for maintenance at Burloak Park

### **Capital Program Funding**

\$9.9M additional capital funding





# Investments – Managing Risk

### **Staffing Investments**

- Health and Safety Associate
- Cyber Security Analyst



### **Other Investments**

- Non-union market competitiveness
- \$50K one-time funding for cyber security resilience
- \$75K one-time funding for IT Service Desk Support
- One-time funding for a Plumbing Grant Program
- Steps to Safety Home Visit Program





# Investments – Building a 21<sup>st</sup> Century Workforce Staffing Investments Other Investments

- 2 Business Intelligence positions
- PT AV specialist
- Engagement and Volunteer Coordinator

- \$180K one-time funding for a job evaluation system
- \$75K one-time funding for a Diversity and Inclusivity strategy
- One-time funding to support the ERP project team









# Investments – Managing Community Growth Staffing Investments Major Community Plans

- 11 additional positions to support the Development Application and Review Process
- 1 Building Technologist
- 1 Solicitor Planning and Development





- \$2.138M of one time funding for:
  - Official Plan (\$600K additional funding)
  - Major Transit Station Area (MTSA) planning project (\$500K additional funding)
  - Zoning By-law Review (\$538K)
  - Integrated Transportation Plan (\$300K)
  - temporary external planning resources (\$200K)





# Investments – Addressing Climate Change

### **Staffing Investments**

- 5 Private tree by-law positions
- 1 Climate Action Plan position



### **Other Investments**

- \$100K increased investment in tree planting
- \$865K one time funding for Forestry:
  - Protection of trees from invasive species (\$565K)
  - update of the Urban Forestry Management Plan (\$300K)
- \$60K one-time funding to complete Burlington Climate Change Adaptation Plan
- \$32K one-time funding to support Bay Area Climate Change Partnership





## **Investments – Enhancing Services**



### Recreation

- 2.8 Adult Seniors Programming positions
- New Splash Pads at Tansley Woods and Brant Hills
- New City View Park Pavilion



### **Transit**

- 7 additional conventional buses
- 2 additional specialized vehicles
- 16 new operators
- Free Transit
  - SPLIT pass
  - Children 12 and under
  - Seniors (pilot)



### **Culture**

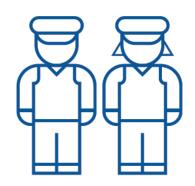
- \$25K increase in Cultural Fund grant
- One-time funding for additional staffing at newly renovated Joseph Brant Museum
- One-time funding Cultural Diversity Initiative at Burlington Performing Arts Centre



# Investments –Addressing COVID-19

### **By-law Enforcement**

 2 temporary By-law Enforcement Officers (supported by Region of Halton)



### **Community Support**

- Tax relief program
- \$250,000 small business fund
- Free transit and parking
- Free masks
- Reduced facility rental fees and increased fee assistance



## Addressing COVID-19 – Budget Approach

2021 Operating Budget - Two Budgets in One

#### On-Going Budget

- Base budget plus priority risk mitigation measures
  - Resulted in a tax increase

### 2021 COVID Budget

- Temporary revenue losses & increased expenses
- Offset by temporary cost savings and Safe Restart funding
