City of Burlington By-law 62-2021

A by-law to amend By-law Number 39-2016 and By-law Number 40-2016 being a by-law to regulate parking and idling in the City of Burlington and a by-law to provide for a system of administrative penalties and administrative fees for parking infractions in the City of Burlington

Whereas Section 102.1 of *the Municipal Act*, 2001, S.O. 2001, c.25, as amended, and Ontario Regulation 333/07 authorize a municipality to require a person to pay an administrative penalty if the municipality is satisfied that the person has failed to comply with any by-laws respecting the parking, standing or stopping of vehicles; and

Whereas the Corporation of the City of Burlington has enacted a by-law regulating the parking, standing or stopping of vehicles, namely By-law 39-2016 being a by-law to regulate parking and idling in the City of Burlington; and

Whereas the Corporation of the City of Burlington has enacted By-law 40-2016 being a by-law to provide a system of administrative penalties and administrative fees for parking infractions in the City of Burlington; and

Whereas the Council of The Corporation of the City of Burlington deems it appropriate from time to time to amend By-law Number 39-2016 and By-law 40-2016;

Now therefore the Council of the Corporation of the City of Burlington hereby enacts as follows:

- 1. Schedule "2" of By-law 39-2016 is deleted in its entirety.
- 2. Schedule "2" is added to By-law 40-2016 as follows:
