



**SUBJECT:** Public Tree Removal Report – 5209 Stonehaven Drive

### **Recommendation:**

Approve the request by the applicant to remove three (3) public trees in order to proceed with the proposed Plan of Subdivision application File No. 510-01/17 as outlined in roads, parks & forestry department report RPF-27-21; and

Instruct the applicant, Don Husack on behalf of Dawn Victoria Homes, to provide compensation for the public tree removals by providing cash-in-lieu of replacement totaling \$6,500.00. The funds will provide for new tree plantings elsewhere in the City which includes care and maintenance for the first two (2) years; and

Direct that a tree permit be obtained for the removals and the associated development related permit fee of \$680.00 plus HST; and

Direct that all associated costs with respect to the removal of the trees (including stump removal) will be the responsibility of the applicant. The contractor hired to remove the trees will require approval by the Manager of Urban Forestry or designate.

### **PURPOSE:**

## Background and Discussion:

The subject property is located along Stonehaven Dr., which will be developed into a subdivision consisting of 10 detached single-family dwellings and an 8-unit townhouse block (See Fig. 1).

Forestry staff inspected the site on October, 15 2021. An application for Plan of Subdivision (File No. 510-01/17) has been submitted to redevelop the subject property into 10 detached single-family dwellings and an 8-unit townhouse block. As part of a condition to satisfy their Plan of Subdivision, a Tree Permit must be obtained in order to facilitate the removal of public trees in order to proceed with approval and service the lots. In accordance with the City of Burlington's Public Tree By-law 68-2013, Section 1.19 states, "*The City Arborist shall not issue a Tree Permit for Trees located on Public Property immediately abutting Private Property for which a development application has been submitted, until such time as the development application has been approved and Council has also approved the removal of these trees*".

### **Strategy/process**

Three (3) public trees are proposed to be removed due to conflicts with the proposed Plan of Subdivision. More specifically, three (3) trees will directly conflict with the proposed road construction and servicing for the proposed development (Tree No. 5, 6 and 11) as described within the Arborist Report submitted as Appendix C. The subject trees that are proposed for removal are located along the boulevard of Stonehaven Dr. The trees proposed for removal are as follows:

1. Tree No. 5: Thornless Honey Locust (*Gleditsia tiacanthos* var. *inermis*): DBH 28cm
2. Tree No. 6: Thornless Honey Locust (*Gleditsia tiacanthos* var. *inermis*): DBH 22.5cm
3. Tree No. 11: Thornless Honey Locust (*Gleditsia tiacanthos* var. *inermis*): DBH 22.5cm

All of the trees proposed for removal are mid-size and considered to be in good condition in both health and structure at the time of assessment. Given the proposed plans and constraints of the subject property for access as it is bound by a rail corridor, public park and regional road (Dundas Street), there were limited locations for access for the subject property. Similarly, there is a number of servicing proposed for the new subdivision. Due to the amount of encroachment and overall scope of work and duration, it was not feasible to retain the trees. As such, Forestry is in support of the removal of the above noted subject trees under the provision that cash-in-lieu fees are provided to the City as compensation for canopy loss. Note, Public Tree No. 10, has since been removed by City staff due to condition. All private tree removals will be dealt with through the *Planning Act* process.

### **Options Considered**

Forestry staff conducted a comprehensive review of the proposed plans with the applicant. Additional public trees along Stonehaven Drive and more specifically along the frontage of John William Boich Parkette will be preserved during servicing work by implementing directional bore methodology.

### **Financial Matters:**

A total of \$6,500.00 shall be paid by the applicant as compensation for the tree removals. These funds will be utilized to replace the loss in canopy within the City. In addition to the cash-in-lieu fees, a permit fee of \$680.00 plus HST will be required. The total cost of tree and stump removals will be borne entirely by the applicant.
