Provincial Regulations

As of September 22, 2021, Ontarians will need to be fully vaccinated (two doses plus 14 days) and provide their proof of vaccination along with ID to access certain public settings and facilities. This approach focuses on higher-risk indoor public settings where face coverings cannot always be worn and includes:

- Restaurants and bars (excluding outdoor patios, as well as delivery and takeout);
- Nightclubs (including outdoor areas of the establishment);
- Meeting and event spaces, such as banquet halls and conference/convention centres;
- Facilities used for sports and fitness activities and personal fitness training, such as gyms, fitness and recreational facilities with the exception of youth recreational sport;
- Sporting events;
- Casinos, bingo halls and gaming establishments;
- Concerts, music festivals, theatres and cinemas;
- Strip clubs, bathhouses and sex clubs;
- Racing venues (e.g., horse racing).

Current Practices

In addition to the new provincial regulations, the city of Burlington's health and safety practices remain, these include:

- Active screening
- Physical distancing
- Capacity limits
- Cleaning protocols
- Encouraging hand washing/ sanitizing

Proof of Vaccination is an additional measure added to this list as of Sept 22.

Regulations Requirements

In keeping with the [provincial regulations](#) and [guidance](#), effective Sept. 22, 2021, individuals entering **indoor** facilities used for the following purposes (unless otherwise exempt) will be required to be fully vaccinated (as defined in the provincial [guidance](#)) and provide proof of vaccination, along with identification:

- Sports
- Recreational fitness activities
- Meetings
- Events



Planning for EVC

To prepare for this change, city employees have been busy doing:

- Interpretation of the regulations
- Understanding what our municipal colleagues are doing
- Preparing and implementing a communication plan – user groups
- Working to secure staff and a security company to implement the EVC
- Developing training documentation
- Onsite logistics (e.g. signage, set-up, stanchions, exemption process)
- Orientation video
