- 1. Climate Action Plan
 - a. **Home Energy Efficiency Retrofit Program** report being finalized with recommendations being made to the Environment, Infrastructure & Community Services Committee March 3rd.
 - Electric Mobility Strategy agreement signed with BurlingtonGreen to complete community based strategy. Developing workplan and community engagement strategy. Also working with an agreement with Plug'n Drive to bring their mobile test drive centre to Burlington for a four week period starting April 23rd (by appointment).
 - c. **Renewable Energy** working with McMaster University's Masters program for Engineering and Public Policy to research municipal best practices to support renewable energy in the community. Three students are working on the project and are creating a workplan for the project. There will be a community engagement component. Project to wrap up by August 2022.
 - d. **Sustainable Building & Development Guidelines** updated guideline presented by Community Planning to the Community Planning, Regulation & Mobility Committee on December 7th.
 - e. Integrated Mobility Plan Transportation staff presented the Preferred Network Solution to Committee for endorsement to Community Planning, Regulation & Mobility Committee on December 13th. Council endorsed, in principle, the Preferred Network Solution and have directed staff to proceed with the last phase of the work. The Preferred Network Solution is the balanced approach.
