A by-law to amend By-law 39-2016 being a by-law to regulate parking and idling in the City of Burlington File: 745-01 (RCC-02-21, TS-12-21, TS-11-21)

Whereas Section 11 of the *Municipal Act, S. O. 2001, Chapter 25*, as amended authorizes municipalities to enact by-laws regulating parking; and

Whereas Council deemed it appropriate to enact by-law 39-2016, as amended, to regulate parking and idling in the City of Burlington; and

Whereas on April 20 2021, Council approved item 10.4(e) following the Environment, Infrastructure & Community Services Committee Meeting recommendation (report RCC-02-21) to amend Parking and Idling By-law 39-2016 to accommodate a trailer parking fee at LaSalle Park Community Marina; and

Whereas on December 14 2021, Council approved item 12.4(a) following Community Planning, Regulation, & Mobility Committee Meeting recommendation (report TS-12-21) to amend Parking and Idling By-law 39-2016 to provide ten annual passes to exempt Halton residents from paying parking fees on weekends to park at Beachway park between May and September for the calendar year 2022; and

Whereas on November 23 2021, Council approved item 12.3(e) following Community, Planning, Regulation & Mobility Committee Meeting recommendation (report TS-11-21) to amend Parking and Idling By-law 39-2016 to cease the 90-minute waived parking fees pilot program in the Burlington Downtown Business Area boundary and reinstate paid hourly parking within the downtown effective December 1, 2021.

Now therefore the Council of The Corporation of the City of Burlington enacts as follows:

- 1. Schedule "1" of By-law 39-2016 is deleted in its entirety and replaced with a new Schedule "1" attached as Schedule A to and forming part of this by-law to remove boat trailer parking timeframe, add Halton Beachway passes for residents, add Beachway timeframes and remove waived 90-minute parking with minimum payment.
- 2. That in all other aspects, By-law 39-2016, as amended, be and is hereby confirmed.
- 3. This By-law comes into force on the date of its passing.
