A By-law to amend By-law 61-2021 being a by-law to regulate rates and fees in the City of Burlington File: 435-03 (RPF-08-22)

Whereas sections 8, 9 and 11 of the *Municipal Act, 2001*, as amended, authorize the City of Burlington to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the City of Burlington; and

Whereas Section 391(1) of the *Municipal Act, 2001*, as amended, authorizes The Corporation of The City of Burlington to impose fees and charges on persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control; and

Whereas Council of the City of Burlington has deemed it necessary to amend certain rates and fees in By-law 61-2021, as amended; and

Now therefore the Council of The Corporation of the City of Burlington enacts as follows:

- 1. The section entitled "Service: Urban Forestry" of Schedule A of By-law 61-2021, as amended, is hereby deleted and replaced in its entirety with the section entitled "Service: Urban Forestry" attached to this by-law.
- 2. That in all other aspects, By-law 61-2021, as amended, be and is hereby confirmed.
- 3. This By-law comes into force on the date of its passing.
