#### **Situational Update**

- Province's Chief Medical Officer of Health is maintaining existing provincial masking requirements in select higher-risk indoor settings until June 11, 2022, including public transit.
- As of May 1, 2022, the City's Health, Safety and Wellness team will continue case and contact management and tracking for Fire. All other services will see supervisors/leaders responsible for managing the impact of COVID (cases and isolation) on service operations. To support this change, all employees will be provided with instructions about what to do if they are sick or at risk of COVID-19, including isolation requirements.
- Within City facilities and operations, workplace COVID-19 safety protocols will remain in place until June 11:
  - Mandatory masking for staff will continue, including in City vehicles. Where workstations are more than 2m apart, masks may be removed.
  - With limited exemptions, mandatory masking will continue to be required for in-person meeting/training (Council Chambers exempt, with distancing in place).
  - Physical distancing continues with limited exceptions. Capacity limits within facilities will increase with the move from 1 person per 8 square metres, to 1 person per 4 square metres.
  - City facilities will continue to have passive screening signs at entry points.
  - Employees will continue using the online active screening tool at the beginning of each shift at burlington.ca/screening.
  - The City's COVID-19 Staff Vaccination Policy will remain in effect, including mandatory regular testing, where required by the policy.
  - HVAC enhancements in City facilities, including higher efficiency filters and increased outdoor air will continue as will disinfection of high traffic touch points twice a day at City facilities.
