



- Trumpeter Swan

- City hasn't amended Bylaw 083-2015 as it undertook to do at the Stakeholder meeting in 2018 and in the Addendum to EA for wavebreak



No Cost To The Taxpayer?

- From the Report "A staff working team has been established to investigate all related matters. This will require a significant amount of staff time and may impact other priorities."
- Who pays for all the Staff time? Is LPMA going to be billed for those costs? Staff don't work for free.
- "Opportunity Cost"?
- Does this affect the report on JV's that has been delegated to Staff since the Council in 2018.

LPMA Finances?

- From Report "The LaSalle Park Marina Association must continue to meet all its financial obligations to the City"
- How?
- From Report "transitioning all administrative and financial aspects of the operation"
- LMPA has no revenue if all financial aspects are taken over by the City.
- This is what happens when you move fast and break things.

The Way Forward?

- If Staff can actually find a no cost way to take over the Marina by June 15. Great. But lets have the business plan.
- What's Plan B?
- Boaters want to use their boats how do they get them out of storage?
- Personally I would like to see the Public Boat Launch closed, but there are people who would like to use it. At least 625 people used it last year.
- Is the Sailing School able to Operate out of the Public Launch ramp BS&BC have privatized? What about Able Sail?


Long Term

- Staff should be directed to report with a business plan at the September EICS.
- If there is no permanent solution then the Boats shouldn't go back into storage on the Pier.
- The Touristics report in 2019 established that the Marina is too small to be commercially viable. It also lacks amenities that the other Marinas in the region provide.
- The solution is to expand to the 300+ slots that were originally envisioned by LMPA and getting a contractor to run the Marina. There will be costs but expansion can be planned and amenities can be added over time.

Long Term continued

- Since council determined that we have a climate change emergency there needs to be a plan to transition to Sail/electric and get rid of the inefficient Marine engines.
- Jetskis should be banned at the Public Boat Ramp. The are noisy and they are not "Bird Friendly" <u>See Jetskis at www.stopthrillcraft.org</u>
- Assuming the lease is extended then Staff should be directed to come up with a long term plan for the park given its proximity to the Aldershot Go Station.
- There needs to be some sort of public meeting to consult with all stakeholders, not just the boating special interest group.
