
Let us first commend you on being the only staff or council member associated with BNOP who has at least tried to answer our questions that were associated with our end of life property next to the Molinaro Development that was causing us much anxiety in terms of whether we were part of the UGC or not. As it turned out **the city had included our property in the UGC but it had to be removed to conform with ROPA.**

Your letter before Council and its last paragraph contained in the subject line has lead us to ask questions but have been unable to get answers from the City, the Region or the OLT . This leads us to believe the answer to each question is “does not exist” or “did not occur” and all we need from you at this time is confirmation that we are correct in our understanding by a Yes or No answer to our questions : just circle the right answer.

1. Did the non-conformity letter from Curt Benson received by the Mayor and described by the Mayor and Heather McDonald at the first Planning and Development Committee meeting in the 2018 – 2022 term of Council, chaired by Paul Sharman, ever go to Planning and Development or Council. YES OR NO
2. Is there any kind of communication between Angela Morgan and Graham Milne or the Region Council in terms of compliance with the By-law approved by Burlington Council on April 24, 2018. YES OR NO
3. Was BNOP ever before Regional Council. YES OR NO.

Our research shows the answers are NO, NO, NO. If your answers are any different Alison please provide the proof of such so we can let this matter, that sees no Burlington Official Plan be put to bed once and for all.
