Heritage Planner Update- July 26, 2022

1. Downtown Cultural Heritage Landscapes Study- Evaluation of individual properties for Heritage Register status

Summary

- On July 5, 2022, the Community Planning, Regulation & Mobility Committee recommended that City Council approve the staff recommendation to authorize the Downtown Cultural Heritage Landscapes Study and add eight properties to the Municipal Register of Cultural Heritage Resources while the study is ongoing. The Committee also added the following direction:

*“Direct the Director of Community Planning to connect with the Heritage Burlington Advisory Committee to reconvene and review each property in the cultural landscapes to determine which should be added to the Municipal Register; and
Report back to the Community Planning, Regulation & Mobility Committee meeting on September 13, 2022.”*

- Staff completed the evaluations and sent to the Evaluations subcommittee on Friday, July 15

Heritage Burlington is asked to:

- Review the Individual Heritage Evaluations for candidate properties in CHL’s 1,2,4 & 5**
- Review the Evaluations Subcommittee recommendation**
- Choose one of four options:**

1. That Council add all staff-recommended properties to Heritage Register

That the Heritage Burlington Advisory Committee recommends that City Council add 353-355, 359, 361, 372-374 and 380 Brant Street; 2003 Lakeshore Road; 404-408 John Street; 458, 488, 513, 524 and 1445 Locust Street; 2010 Maria Street; 468 Elizabeth Street; 431 and 435 Pearl Street; 422,426 and 437 Burlington Avenue and 1415 Lakeshore Road to the Municipal Heritage Register.

2. That Council add staff-recommended properties to Heritage Register, re-assess when the study is finished

That the Heritage Burlington Advisory Committee recommends that City Council add 353-355, 359, 361, 372-374 and 380 Brant Street; 2003 Lakeshore Road; 404-408 John Street; 458, 488, 513, 524 and 1445 Locust Street; 2010 Maria Street; 468 Elizabeth Street; 431 and 435 Pearl Street; 422,426 and 437

Burlington Avenue and 1415 Lakeshore Road to the Municipal Heritage Register; and.

That following study completion, staff re-assess the eligibility of the above listed properties for continued inclusion on the Heritage Register and report back to City Council with a recommendation.

3. That Council add revised list of properties specified by Heritage Burlington Advisory Committee to Heritage Register

That the Heritage Burlington Advisory Committee recommends that City Council add ***properties listed by Heritage Burlington*** to the Municipal Heritage Register.

4. That Council decline to add properties to add further properties to the Heritage Register

That the Heritage Burlington Advisory Committee recommends that City Council decline to add any further properties to the Heritage Register, pending the outcome of the Downtown Cultural Heritage Landscapes Study in Q3-4 of 2023.
