City of Burlington By-law 64-2022

A by-law to appoint Municipal Law Enforcement
Officers for the City of Burlington and to repeal By-law 35-2022
File: 745-06 (CL-31-22, DA-70-22)

Whereas Section 15 of the *Police Services Act*, R.S.O. 1990, c. P.15, as amended, authorizes municipal councils to appoint one or more Municipal Law Enforcement Officers for the purpose of enforcing the by-laws of the municipality;

The Council of the Corporation of the City of Burlington hereby enacts as follows:

1. That those persons so named on Schedule "A" attached hereto and forming part of this by-law be appointed as Municipal Law Enforcement Officers.
2. By-law 35-2022 be hereby repealed.
