Dear Mr. O'Reilly or City Clerk

Please be advised that we purchased the property on 488 Locust St under the assumption that this property is not registered or designated as heritage and can be demolished. We verified this assumption of the heritage status during our purchase condition period by contacting Community Planning, Mr. John O'Reilly, and received the email below in BLUE which states that the property is not registered nor designated as heritage; and that the structure can in fact be demolished. We even started the Pre-Demolition process that was signed by (John O'Reilly Planner II - Heritage Community Planning) the City of Burlington as attached stating that property can be demolished. We then removed our condition and completed the purchase of the property.

Just for your information and this information has nothing to do with my decision in purchasing this property I am betting on the information and signature I have received from the city, this is only my opinion, this property is covered by vinyl siding which was introduced to the Construction Industry in 1950's and some time in 1970 and 2000 this property was changed and remolded with vinyl siding and additions were added sometimes in between 2000 to 2015. As well, the whole porch has been remolded to provide accessibility for wheelchair (the property was used for Doctor office). Nothing Original remains on this property such as actual size or shape or construction material used as far as I see it.
