I think the strategic plan directions could be stronger to support this SDG - for consideration in next edition. Although the Region is the lead on social services, there are actions that the City can take to help to eradicate poverty..

Again, I think the strat plan directions could be stronger - nothing really in the strat plan about supporing sustainable agriculture (this did come up in Climate Resilient Burlington). Strongest link is under Healthy & Greener City - 'residents grow their own fresh and healthy food. I would recommend in the future that it be re-worded: 'Residents have opportunities to grow their own fresh and healthy food' recognizing that many people living in multi res buildings have limited opportunity with the exception of community gardens.

Strong links here to Strat plan under Healthy and Greener City.

Could improve strat plan link - the city does partner with school boards and we're working to bring Brock University to Burlington. For P&Os, I would add q

Could the strat plan be stronger in this area? Being inclusive & diverse doesn't always mean gender equality.

Agree that the Region is the lead here on treatment and distribution and ww collection, but we could include wording related to source water protection - we all have a responsibility to ensure our water sources are kept clean (source water protection) I don't see the link in 'A City that Grows'. And it should be stronger in Healthy and Greener City, although it could be implied given that we are working towards being net carbon neutral. However, energy poverty is an issue. Next edition of strat plan could be strengthened. I think you could make the point that there is a link to the 5th principle. Suggest including P5 and h objective Similar comment to SDG #5 - could strengthen wording related to equity, opportunities. no comments here no comments here I would add A City that Grows for link to Strat Plan. Other plans to note: new Official Plan (there is a section dedicated to climate change); the Integrated Mobility Plan; and the Corporate Energy & Emissions Management Plan. For P&Os, would suggest adding j and l

Some connection to A Healthy & Greener City. Ok... we're not close to a 'sea' but would argue that the Great Lakes are fairly significant. We have objectives for a healthy, natural heritage system (which would include waterways); a clean, safe and useable waterfront; and leadership in SW management and low impact development.
