- 1. Additional Safe Restart Agreement Funding
- 2. Increasing attainable housing options
- 3. A second round of Streamlined Development Application funding (SDAF) so we can continue to target streamlining processes for housing approvals.
- 4. A commitment from the Province of Ontario to work together with municipalities and other key stakeholders on implementation of the Ministry of Municipal Affairs (MMAH) Housing Supply Action Plans starting with Bill 23, the More Homes Built Faster Act.
- 5. The Province strike a task force, with participation from all stakeholders, to consider options for streamlining and making the Ontario Lands Tribunal more efficient.
- 6. The City of Burlington is "made whole", by the Province for the revenue reductions associated with the implementation of Bill 23, More Homes Built Faster Act, 2022.
