Bill C-233, “Keira’s Law” – Legislation requiring federal judges to be educated on intimate partner and family violence.	Motion Memo - April 19, 2022, Council <b>Outcome</b> - Bill C-233 received Royal Assent. The Province of Ontario also passed legislation in support of the Bill C-233.
Release of Federal and Provincial Documents Related to the Former Mohawk Institute Residential School	Motion Memo - January 24, 2023, Council <b>Outcome</b> – Federal government announced the establishment of a new Residential School Documents Advisory Committee. The committee is tasked with developing recommendations for how to identify historical documents related to residential schools and share them with the National Centre for Truth and Reconciliation.
A call to the Provincial government to End Homelessness in Ontario	Motion Memo – March 21, 2023, Council <b>Outcome</b> – the Province of Ontario committed an additional \$202 million annually to homelessness prevention programs. A delegation from the Ontario’s Big City Mayors (OBCM), which included Mayor Meed Ward, OBCM Vice Chair met with Deputy Premier and Minister of Health Sylvia Jones
Calling on the Province of Ontario to Fund the Third-Party Audit Program	Motion Memo – April 18, 2023, Council <b>Outcome Sought:</b> Provincial funding of the third-party audit of the City’s development charges and park dedication impact analysis reviews in order validate and provide provincial funding to address the City Burlington’s growth-related revenue shortfalls created by recent legislation changes.
City of Burlington Expectations Regarding Provincial Review of Regional Governments	Motion Memo – May 3, 2023 (CSSRA), May 16, 2023, Council <b>Outcome Sought:</b> To engage council in a discussion on the principles and outcomes related to the expected Provincial review of regional governments. The expectations will be forwarded to the Minister of Municipal Affairs and Housing. (Unanimously supported)
Legislative Amendments to Improve Municipal Codes of Conduct and Enforcement	Motion Memo – May 16, 2023, Council <b>Outcome Sought:</b> After consulting with municipalities, the Province of Ontario introduces and passes new legislation that strengthens municipal Codes of Conduct and compliance with them. And also, municipalities and their respective Integrity Commissioners are consulted on the development of any regulations related to the proposed legislation.
