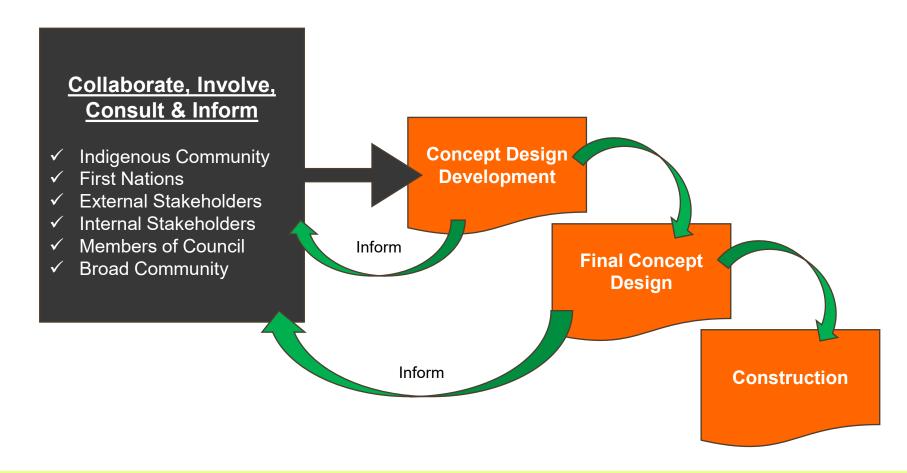

Concept Plans: Phase 2 Engagement Overview

Engagement is critical to this project and is built into all stages of design development.

Phase One of engagement began in September 2023 and was complete in February 2024.

Phase Two of engagement began in March 2024 through June 2024.



Concept Plans: Phase 2 Engagement Key Findings

To understand the extensive feedback received during Phase Two engagement, a Decision Matrix was used as a tool to evaluate and understand both the overall preferred option and the various design elements.

Preference for design elements by major stakeholder group (i.e. city staff, city council, advisory committees, and the public) were assigned a rating of:

- 1 point (not preferred),
- 5 points (moderate preference), or
- 10 points (most preferred)

The sum of the ratings provided for each design feature across stakeholder groups assists in understanding preferences.

Concept Plans: Phase 2 Engagement Key Findings

Option #2: Atrium is the framework for the 'Preferred Master Plan' with the following modifications:

- Replace the atrium element with the vestibule entrance as per Option #3.
- Maintain a focal point canopy with branding at Brant Street / James Street.
- Incorporate a focal point canopy with branding at Elgin Street as per Option #3.
- Provide continuous canopies along the building façade as per Option #1.
- Maintain size, configuration, and flow of exterior spaces, including '3 Rooms' approach.
- Incorporate a 50% reduction in parking as per Concepts #1 and #2.
- Provide a variety of seating elements as per Concept #1.
- Incorporate flag poles adjacent to building entrance as per Concept #1.
- Incorporate an in-ground water feature (Water Jets) as per Concept #3.
- Incorporate trees and planting as per Concept #3.
- Incorporate the 'Waves' themed patterning in paved surfaces, as per Concept #1.
