Executive Summary:

On February 12, 2024, a formal complaint was submitted to the City's Ombudsman (ADR) Chambers to investigate the City's conformity to the *Municipal Act, 2001*. The nature of the complaint is that the city improperly held a Pipeline to Permit Committee meeting on February 8, 2024, without the committee being defined in the City's Procedure By-law. It is recommended by the Ombudsman that the city follow up on its acknowledged statement of intent to update the Procedure By-law to reflect that the Pipeline to Permit Committee is a Standing Committee of the City and note its meeting schedule. The Ombudsman notes this is to aid consistency in how the Procedure By-

law treats the City's Standing Committees but doesn't arise from any binding legal requirement to do so.

Background and Discussion:

The purpose of this report is to transmit a detailed report dated August 27, 2024, for committee review and consideration from the City's Ombudsman (ADR Chambers).

The nine-page report along with the covering letter from the Ombudsman is contained in Appendix A and is based on a formal complaint which commenced on February 12, 2024. The nature of the complaint is that the city improperly held a Pipeline to Permit Committee meeting on February 8, 2024, without the committee being defined in the City's Procedure By-law.

The City Clerk, as noted in the report was conducting a review of the Procedural By-law in fall 2023 with changes being brought forward in September 2024 which would include adding the Pipeline to Permit Committee to the roster of listed Standing Committees and amending relevant sections to reflect its addition.
