3	STOLTE:	Okay, moving on to the rest of our CSSRA regular items. We're going to
4		be looking at Procedure By-aw update report CL-01-24. At this time, I'd
5		like to pass it over to Blake Hurley, our Commissioner of Legal and L-,
6		Legislation Services/City Solicitor, who's gonna provide some
7		introductory remarks, please.
8	HURLEY:	Uh, thank you, uh, Chair Stolte. Uh, if I could ask, uh, uh, AV to put the-,
9	11:09	a couple PDF slides up on the screen. And I should also note that with me
10		today is, uh, Samantha Yew. Uh, she's feeling a bit under the weather, so
11		is attending, uh, electronically, so both of us will be here to answer, uh,
12		Committee and, uh, Committee's questions on this matter. And if we
13		could go to the next slide, please. So I just wanted to start before we get
14		into, uh, Committee's questions about this, about what the Municipal Act
15		requirements are in relation to a Procedure By-law. So Section 238 (2)
16		and (2.1) of the Municipal Act require that every municipality shall pass a
17		Procedure By-law for governing the calling, place and proceedings of
18		meetings, and for the provision of public notice. And I wanna highlight
19		that those are the only elements of the Procedure By-law that are required
20		by the Act. All other elements are at the discretion of Council. Uh, if we
21	11:10	could go to the next slide, please. So what that means, effectively, is that
22		the City's Procedure By-law should reflect how Council wants its
23		meetings to run. And what I can say about the Procedure By-law that is in
24		front of you, uh, for consideration is that the proposed by-law meets the
25		requirements of the Act and is reflective of Staff's recommended meeting
26		structure and procedure and really how, uh, Committee meetings have
27		been running. I know that in the past while we've had to, uh, sometimes
28		vary from the requirements, the Procedure By-law, which is again a
29		permitted, uh, Council is permitted to do that. Uh, so these Procedure By-
30		law amendments have tried to address this, uh, uh, certain matters that
31		Council will sometimes seek to vary from, and pr-, provided in a way that

1		will provide Committee the ability to move smoothly and flow freely
2	11:11	through the, uh, their meetings using the Procedure By-law. So should
3		Council, after reviewing this or after discussion, wish to add or remove
4		elements, uh, of the by-law, then, uh, Staff would recommend that
5		motions be put forth to do so and, and the reason I say that is that, again,
6		this is Council's by-law. And certainly, there are, uh, certain members of
7		Council or some members of Council that might like certain things and
8		other members of Council who don't like certain things, but ultimately it's
9		a Council decision as to what has to be included in this by-law. So we
10		would suggest that rather than we hear things from, uh, members that we
11		add that might not be supported by all members, we've suggested this
12		occur through, uh, motions, uh, that are needed. We heard comments
13		today from, uh, delegates with respect to the timing. Uh, certainly I, I, I
14		would say that there's no ideal time to, to bring these things, uh, forward,
15		um, due to changes from going back to 2023. We had changes in the
16	11:12	staffing of the Clerk's Department, uh, then we had a new City Manager
17		coming on board with a, a different, uh, vision of how committees would
18		be structured, um, uh, moving away from the three to a Committee of the
19		Whole. And then, um, we had, um, wanted to make sure that we ground
20		truth this with members of Council and meet individually with everyone to
21		make sure that happens. So that certainly has added to the time that, uh,
22		we-, we've, uh, that the reason why this is being brought now and not four
23		or five months ago, but it is before you here now. And I will say that we
24		could certainly, there's calls to defer it, uh, you could kick this further
25		down the road and do much more consultation on it. That certainly is, is a
26		possibility. Again, this is your By-law, uh, and the way you want, uh,
27	11:13	Committee and Council to run. Uh, so Staff is recommending the by-law
28		before you, happy to take questions on it and, uh, consider any input.
29		Thank you.
30	STOLTE:	Thank you, Blake. Are there any questions for Staff at this time?

1	KEARNS:	I'd just like to hear from Staff what the implication would be for a deferral
2		through to October possibly, um, using the words, uh, that a
3		recommendation that a motion put forward for any changes that we'd like
4		to see. I've got about three pages of notes, uh, that I don't know if this
5		Committee wants to go through one by one in terms of, uh, potential
6		motions. So Kelvin, I'm very excited about that. Uh, so what would be
7		the implications further to my e-mail on Friday if we were to defer by, uh,
8	11:14	one month?
9	HURLEY:	Thank you. Through the Chair, uh, certainly a deferral, uh, is a
10		possibility. I think the first deferral we could look at is whether or not this
11		should be for deferred to Council and whether or not, uh, those changes
12		can be considered during that timeframe. I-, if we are to defer and, and I
13		think one of the delegates had mentioned this as well is that the, uh, one
14		item that could be, uh, dealt with at this time is an amendment to the
15		existing by-law to reflect the Pipeline to Permit Committee. If you were
16		to do that, then the deferral could take place, whether it's October, whether
17		it's November, whether it's December, uh, we could certainly talk about an
18		ideal or appropriate time for that, but that would be the mechanism to do
19		that. So I-, I'd suggest first that Committee would want to consider
20		whether or not if a deferral is necessary, first of all, and then whether or
21		not a deferral to Council would be the appropriate time to consider any
22		matters or motions in between, uh, from today, uh, and, and reflect them at
23	11:15	Council. And if not, then, uh, look to an amendment to the By-law to
24		reflect P2P to have Council approve this September cycle and then defer it
25		further for further discussion, uh, and to a upcoming Committee,
26		Committee, whether that's October, uh, I know we've heard, I think, from
27		a Council Bentivegna today, there's some, some absences that will take
28		place at the October round of meetings. So whether or not November
29		might be the, the better time for that.
30	KEARNS:	Okay. And just to confirm, so I did, um, quickly check the Municipal,
31		um, Act and we can't use a temporary by-law for this type of procedural

1		thing. It's only limited to land use and other matters, correct?
2	HURLEY:	Uh, through the Chair, that's correct. This wouldn't be a temporary by-
3		law. This would be an amendment to our existing Procedure By-law. Uh,
4		and just to back up for clarity, what's being proposed to, uh, by Staff to
5		Committee and Council is a new Procedure By-law. This would repeal
6	11:16	the existing Procedure By-law and introduce a new Procedure By-law. If
7		we're talking about making an amendment to deal with Pipeline to Permit,
8		for example, that would be an amendment to the existing Procedure By-
9		law with a deferral on the rest to come back in the form of a new by-law at
10		some point.
11	KEARNS:	Okay, I think I'm at two, but my follow up to that one would have been,
12		does that include the terms of reference remaining unchanged if a
13		amendment is made to the Procedure By-law, does it also carry through to
14		the terms of reference for P2P and keep them solid, but allow it to be
15		recognized under the Procedure By-law.
16	HURLEY:	Through the Chair and, uh, the City Clerk may want to weigh in on this
17		one as well. Uh, through the Chair, the Procedure By-law does not
18		identify, uh, P2P at this point, and so that would need to occur in order to,
19	11:17	I, I shouldn't say, need to occur. Ideally, that would occur and be reflected
20		in the Procedure By-laws or operating on side our Procedure By law, and
21		not just simply calling Standing Committee, um, uh, Standing Committee
22		meetings in accordance with the Municipal Act. Uh, and Sam, I'll turn it
23		to you as to the terms of reference as it relates to the P2P Committee.
24	YEW:	Yeah. Thank you and apologies for my voice in advance. I'm hoping you
25		can hear me clearly. Um, Blake is correct in that it, it would just be
26		adding the Pipeline to Permit Committee to our current roster of
27		committees as noted in the Procedure By-law, it wouldn't have any effect
28		on the existing terms of reference.
29	STOLTE:	Okay. Thank you very much for that clarity. We have additional
30		questioning first coming from Mayor Meed Ward.
31	MEED WARD:	Thank you, Chair. Um, there are a number of changes to standing

committees noted and times of meetings and a whole structure and, and a whole bunch of things that, uh, I would consider somewhat housekeeping, um, uh, but, you know, we have been at that for two years. So I'm wondering whether the better-, what your thoughts are around us approving this and if Council members have a concern with a pis-, particular section to withdraw that section or refer that particular, so do it the other way around. Approve as much as we can, discuss. I'm certainly interested to hear what, what our, uh, colleagues have to say. Uh, we've got time today on our calendar and, and we've set aside time to discuss this. I'm certainly prepared to, to discuss and, and hope we can do that and use the time available to us. Uh, so wondering what your thoughts are around that and, and then is there any restriction should we wish to amend this regularly going forward? Uh, I'd consider by-laws to be kind of a living document, um, and, you know, we might be in a different situation today if we'd amended along the way rather than save it all up for, for Uh, through the Chair, uh, certainly the-, there is opportunity looking kind of going back from the end of your comment to approve a by-law in the

Uh, through the Chair, uh, certainly the-, there is opportunity looking kind of going back from the end of your comment to approve a by-law in the September round for this to be considered at Committee, for it to go to Council and then once approved, that there be further amendments to it in the coming, uh, months to address any particular changes that, uh, Council as a whole, uh, may decide is, is necessary. So I'd agree, certainly there's nothing that restricts this Council from amending that by-law, uh, in the months to come should amendments be necessary. With respect to the idea of approving and, uh, um, not advancing some of the by-law, uh, approving some of the by-law but not advancing all of the elements of it, I think there is a bit of a danger in that in the sense that this will be a new by-law and so if you are, uh, depending on the, the element I'll call it depending on the element, if you are to approve the by-law, but not approve some elements of the by-law, you would have to make sure that the elements that you're not approving are not core Municipal Act

1		required, uh, pieces because as I was saying earlier, the municipal Act is-,
2		it's fairly narrow with respect to what has to be included in Procedure By-
3		law. And so some municipalities may choose to have a very, very narrow
4		Procedure By-law. Uh, there would be no restriction on this Council from
5		approving that Procedure By-law, uh, that has just the minimum
6		Municipal Act requirements and adding to it as we, we move forward,
7		and, and have further discussion on it. So really, I think that the answer is
8	11:21	it depends on what's being proposed to be a cut out or not.
9	MEED WARD:	Okay. Uh, and just diving right into the two thoughts I had that I would
10		like, uh, Committee to consider as changes, just two from me. The first
11		was around the definition of pecuniary interest, the proposed change to
12		that and for everyone's reference that's, uh, 1.22 in the by-law section
13		1.22, it's on page 27. Um, the-, there's a proposed change to add the
14		language interest in common with electors generally, which actually is, uh,
15		a provision you can rely on not to declare a pecuniary interest. So
16		wondering, uh, Staff's thought, should I bring a motion to retain the, uh,
17		language, uh, or a modified version of the language in the Act that you can
18		see struck through there on your, on your document.
19	HURLEY:	Uh, through the Chair, thank you, Mayor Meed Ward. That is actually,
20		uh, we'd received those comments from you as part of the consultation
21	11:22	and that's something that Staff did go back and, and take a look at and
22		indeed, uh, agree that the definition of pecuniary interest as it appears in
23		the by-law right now is a bit confusing in the sense that it's requiring you
24		to go back. It's relying on a definition of, um, uh, an item within the
25		Municipal Conflict of Interest Act. Uh, Staff has looked at that and thinks
26		the easiest way to improve the clarity there is, uh, change the definition t-,
27		from what is existing to add a single word, and that is the word
28		determined. So, uh, the existing definition, uh, with the addition would
29		read, uh, pecuniary interest means a direct or indirect financial interest
30		determined in accordance with the Municipal contr-, Conflict of Interest
31		Act, and that, uh, in Staff's view would, uh, help clear up that, um,

1		potential iss-, uh, potential non-clarity.
2	MEED WARD:	So do we need to move that or, or is Staff undertaking to do that?
3	11:23	
4	HURLEY:	This-, I, I-, and thank you, uh, uh, Committee Clerk Joanne Rudy for
5		bringing that I had provided these two, uh, amended definitions to, um, the
6		Clerk of the meeting in advance of the meeting. Uh, and these are being
7		advanced by Staff as, as appropriate, uh, changes to the by-law and we'd
8		simply bring those back, uh, for Council's consideration of the by-law ad
9	MEED WARD:	Terrific. Thank you.
10	STOLTE:	Okay. Question for Councillor Galbraith.
11	GALBRAITH:	Thank you, chair. Um, I think mine was kind of answered there, but, uh,
12		just I'll ask it anyway. Um, i-, it is a living document, as the mayor said,
13		and we can make amendments at any time after we pass it, am I correct in
14		that thinking, it's-, we can change this at any time?
15	HURLEY:	Through the Chair, That is correct. Uh, it is, I mean, certainly there's a
16		procedure to do that still. It is a by-law amendment, so it would have to
17		come forth from Staff or Committee to Council's consideration. So that
18	11:24	may be a result of, uh, a Staff direction or, or similar, but it is, it is able to
19		be amended by Committee and Council, uh, as we move forward after its
20		initial passage.
21	GALBRAITH:	Okay. Thank you. And then, uh, my second question, um, one of the
22		delegates was quite concerned about the timing of the arrival of this
23		document being on the addendum. Um, and maybe hear Staff thoughts
24		on, on the, uh, amount of time required or allowed by the public to review
25		it. Um, do we feel that we could provide it-, would a deferral provide
26		more time for that?
27	HURLEY:	Uh, through the Chair, uh, certainly just to, to make sure that there's no
28		question about that, I will say that we, we're not running into any sort of
29		Municipal Act, uh, issue that based on the timing that it was provided.
30		From a, uh, perspective of having this matter considered by Council and
31	11:25	deferring it to Council, uh, I can't speak for the public. Certainly, um,

1		from we could take from a Staff perspective what we hear today, what
2		we've heard from the public delegations and what we've heard or will hear
3		from members of Council in respect of certain sections. Uh, Staff, could
4		certainly commit to doing that review and making those changes in
5		advance of Council for Council's consideration, if that's the, the will of
6		Committee today.
7	GALBRAITH:	Okay, thank you.
8	STOLTE:	Question coming from Councillor Sharman.
9	SHARMAN:	Firstly, thank you for your comments so far. I, I appreciate the complexity
10		of this. Um, as you all know, I tend to be 100,000 feet and 20 years out
11		and getting into the language and the details and that, that I know my
12		colleagues are much better equipped to handle than I. Um, I'm wondering,
13		actually, whether there's a hybrid solution here, um, whereby Staff get all
14	11:26	those lists from people, uh, and, and address them in preparation for
15		Council and then come back with the strategy as to how we fix the
16		existing and by-law right now in Council, um, for whatever we can do
17		immediately is an amendment to the existing by-law. And then what
18		needs to be dealt with in more detail, uh, at a, a later date to be decided.
19	HURLEY:	Through the Chair, if I understand your comment, Councillor Sharman,
20		you are suggesting that we could take that additional information back at
21		this time from members of Council and members of the public, uh, and
22		essentially continue working on that, but bring forth something at Council
23		for an amended bylaw that just covers the core and the necessary pieces.
24	SHARMAN:	Yeah.
25	HURLEY:	Certainly, that is doable. The, the one thing that I will highlight is that
26		we've certainly heard and I know Councillor Kearns, you've mentioned in
27		your comments that you have a, a number of items that you're, you're
28		looking at in the number of different elements that you were looking to
29	11:27	introduce to the by-law. Certainly, Staff has put forward, uh, its view on
30		what is, uh, should be, uh, approved and considered by Council for
31		Procedure By-law. That doesn't-, there's certainly other elements that

1 could be considered if that's the will of Council. So what I wanna make 2 clear is that if we're to take the additional comments from members of 3 Council, I think that it would be really beneficial to have at some point, a 4 decision from Council as to whether or not Council wants those elements 5 included in the by-law because what we, what I'd prefer not to do is to intr-, include all of the elements in the by-law that, um, may or 6 7 may not be appropriate, depending on the will of Council. Um, so that is, 8 I think what we would have to figure out as to the kind of the part two of 9 your, uh, question as to when that comes back, what that would look like 10 11:28 and what form it would, uh, come back in. 11 SHARMAN: Yeah, I agree. Thank you. Um, my concern here and this is a question 12 coming back at you, um, is, is that this is not the first time that we've had 13 an important report come to Staff at the last minute and we've seen some 14 really very serious things happen at the last minute that caused us to have 15 to then do a whole lot of bobbing and weaving at Council meetings, which 16 I actually don't appreciate one bit, um, and nor do the public. And I, I 17 totally agree. So the question becomes one of-, my question will be or I'm 18 gonna look for how we put language in there to, to determine when it is 19 acceptable, because mostly it won't be in my mind to bring things at the 20 last minute, uh, and this is an example of that. So the question is, is this-, 21 it seems to me that we have incomplete Staff work here in terms of the 22 process and getting the Council member the report out early enough, 23 getting the comments back from, from Council so that we would be better 24 prepared for this discussion and that you can now address that in the 25 course of being doing something for Council and then doing something for 26 11:29 later. Is that possible? 27 **HURLEY:** Uh, thank you. Through the Chair and, and that was the reference that in 28 the slide deck that if Council is-, or a member of Committee and Council 29 is interested in a particular change to the by-law, we'd like to have that 30 raised and have that discussion amongst all Committee members, uh, so 31 they can weigh in as to whether or not they're supportive of it or not.

1 Right. Thank you. But not now. Thanks. Going to pass it back to my SHARMAN: 2 colleagues who've got something to say. 3 **KEARNS:** Yeah. I'd like to make this as simple. As possible the. Hang on Councillor Kearns. 4 STOLTE: 5 **KEARNS**: Oh, sorry, sorry, sorry. Sorry, my bad. 6 STOLTE: I appreciate your enthusiasm. About to say over to you, Councillor 7 Kearns. 8 KEARNS: Uh, I just wanna be very mindful that maybe what we do need here is just 9 a referral back to Staff because there are new elements of implemented in 10 11:30 this, uh, by-law, like a verbal update from the CAO, which I take, UH, 11 great exception to. We don't do things just verbally on a standing, uh, 12 basis. It has been-, it was 5:30 on Wednesday that I received my copy of 13 the, uh, draft and it is very difficult to go through such a lengthy 14 document. Uh, one of my questions to Staff was not answered that I 15 tendered on Friday, um, so I think this is incomplete work, uh, as much as 16 I looking forward to it, we also didn't delve into the reason and the 17 insights provided by way of the survey, uh, which had over 100 responses. 18 So I do wanna identify this is not a document negotiation between Council 19 and Staff, this is a document negotiation between three parties, the Public, 20 Council and Staff. And at this point, I feel that one of those voices is 21 severely missing, and so, uh, I'm, I'm happy to table a, a deferral to the 22 11:31 next cycle. I'm happy to refer it back to Staff. Uh, the matter of Pipeline 23 to Permit is a minimal at best to skip or miss one cycle of a Committee is, 24 is something we can do, uh, or we can just approve that and allow it to 25 function, uh, as it should have been already addressed previously and not 26 rushed onto this with essentially 48 hours notice. And I hardly saw the, 27 the presentation that was also issued on Friday with basically zero 28 business days of the presentations from Staff, so I'm not very happy to, 29 um, advance this as Deputy Mayor of Engagement. It's, it's very difficult 30 to do that without the benefit of any engagement, essentially, on this 31 matter. Um, so I will look to Staff with my question being, would you

1		like it referred to the next cycle, would you like to have it referred back to
2		Staff or do you have an alternative?
3	11:32	
4	HURLEY:	Uh, thank you. Through the Chair, a-, as noted in the report, Staff's
5		recommendation, uh, is to for Council to consider it today and approve it.
6		Or I should say Committee, rather, if that is not the will of Committee
7		today and there is an interest in a deferral, Staff would recommend that the
8		matter be deferred into Council in order to go through and address any
9		questions that, uh, are raised and can be implemented within the by-law,
10		with the, with the warning, of course, that is going to lead to some
11		discussion at Council, I would imagine, because there are, uh, elements. I
12		think, that, uh, some councillors are looking to advance or may have
13		questions on that are not, maybe not necessarily recommended by Staff or
14		may not be supported by, uh, the entirety of Council. A further deferral, if
15		the matter was to be further deferred, I would suggest that it be deferred
16	11:33	until November, given that there are some key Staff members away for the
17		October round as well as some members of Council. Uh, but again, that-,
18		uh, if it is deferred until November, it could be deferred straight until
19		November and, uh, with no amendments to the by-law. The other option
20		is to amend the by-law at the, the amend the existing by-law, not bring
21		forward the new by-law, but amend the existing by-law to include
22		reference to Pipeline to Permit Committee. So really those are kind of the
23		options that I would see that, uh, Committee, uh, needs to consider today.
24	KEARNS:	Thanks for that, Blake. So then I guess my, uh, question would be, can
25		you provide this Committee with language that only scopes it to Pipeline
26		to Permit and solves that problem and leaves the rest in abeyance?
27	HURLEY:	Yes.
28	KEARNS:	That's the only thing I would support today. So do we have a path to do
29		that?
30	HURLEY:	Uh, through the Chair, I'll turn it to the Clerk who, uh, her and I have had
31		some initial discussions on this while discussion took place earlier.

1	YEW:	Thank you very much. And through the Mayor or through the Chair, uh,
2		yes, we could-, we can certainly provide some language, um, which would
3		look something along the lines of, um, you know, we would direct Staff to
4		bring forward a Procedure By-law amendment to the September 17th
5		Council meeting to include the Pipeline to Permit Committee and the
6		Procedure By-law and defer the consideration of the balance of. CL-01-
7		24 to the, uh, October cycle or whichever cycle Council or Committee
8		chooses today.
9	STOLTE:	Okay. Thank you for that. I'm seeing Mayor Meed Ward. Are you-, is
10		this questions to the main motion or are you having now conversation with
11		the deferral?
12	MEED WARD:	Is there a motion on the floor?
13	STOLTE:	I believe there's not yet. So you still have a question to what's on the floor
14	11:35	at this time?
15	MEED WARD:	I wish to (inaudible).
16	STOLTE:	Okay, go ahead.
17	MEED WARD:	Go ahead, okay. So, um, a deferral motion can come at any time, and it
18		takes precedence, I'm aware of that. So there's not a motion on the floor
19		so I would really, really value hearing from my colleagues what their
20		potential concerns are about what we've got in front of us. So I am going
21		to move the report just to get it on the floor so that we can have that
22		discussion and receive any other specific amendments. And I'll move it
23		with the two, maybe we can get those back up again, the two that the Staff
24		had proposed. What I'm really concerned about is this conversation going
25		behind closed doors and Staff working on something with individual
26		members of Council. We do our work in public. And, uh, so I think the
27		advice that we have received, uh, today was if folks wish to amend what's
28	11:36	in front of us, then let's bring a motion to do that so that we can have a
29		discussion, so that we can see if the rest of Council shares that. We all
30		had one-on-ones with Staff prior to this coming forward and Staff heard
31		all of our input. Um, they heard it and what is in front of us is what they

1		feel is their best, uh, their best recommendation. Uh, and, and there may
2		not be agreement, unanimous agreement about elements of the by-law, but
3		we do our work in public by majority vote, uh, within the full eyes of the
4		of the community and, and we have been at this, uh, for about two years.
5		So, uh, we have some, uh, I think we have some reputational risk by
6		deferring this, you know, we're asking businesses, we're asking our Staff
7		to speed up their work, to do things quicker, and here we are saying we
8		need more,
9	11:37	more time and I don't know for what. I have spent the last five days
10		myself reading this as I'm sure you all have. I, I had an opportunity to ask
11		questions of Staff, uh, in advance and get those answers. That's the work
12		that we do on all of our reports, and this is no different. And in fact, the
13		delegates had time to read it and give us their feedback so I think the
14		system is working exactly the way it should and we-, uh, I don't see a
15		compelling reason to defer this. Again, uh, we have had time, and we
16		have all had input into this process so, um, so let's, let's proceed or hear
17		from Council members where the concerns are 'cause I don't, I-, that's
18		news to me and, and we still have, you know, four hours left in this
19		meeting to discuss it. Let's do our work today in public. That's what we
20		do at Committee. We discuss, we debate, we put motions on the floor.
21	11:38	We hear from each other and then hopefully we come to a consensus. Uh,
22		so, um, so that, that is what is on the floor, subject to the will of committee
23		to do, uh, something different. Thank you. Oh, and. I actually, I. I will
24		say I, uh, I don't, I don't agree with the two comments around Staff not
25		doing their job or providing us incomplete work. I think the fact that it
26		has taken so long and that the timelines have shifted is exactly because
27		Staff have done an outstanding, very comprehensive look and have
28		adapted month over month to changes that we have brought and given
29		them along the way, including very recently, the change of our whole
30		committee structure and new titles that we want to embed in this
31		Procedure By-law. We don't, we don't wanna delay that any further. So I

1 do actually wanna say thank you to, to Blake, thank you to Samantha and 2 all of the Staff who worked on this. They have gotten, um, undeserved 3 11:39 criticism, I think, from the public and, and here today, and I just wanna 4 say I don't share that view. I think they've done outstanding, uh, 5 outstanding work. This is very comprehen-, comprehensive and, and yes, a lot of reading for us to digest and think about. Uh, and I was happy to 6 7 do that work, uh, over the last four days, including the weekend. Thank 8 you. 9 STOLTE: Okay, I'm gonna jump in with some comments and it's in regard to, um, 10 comments and questions brought forward by Councillor Kearns and in 11 response as far as a potential deferral and comments from the Mayor. Um, 12 I actually tend to agree and support more along the lines of a potential 13 deferral. I understand what the mayor is saying about reputational risk. I 14 think we have more of a reputational risk of as Councillor Kearns brought 15 up not giving efficient and effective opportunity for the public to be able 16 to look at this. The delegations that came forward today were not the first 17 we've heard. We've heard many, many delegations of concern on our 18 11:40 procedural by-law and for this to have come forward last Wednesday 19 afternoon gave two business days before the weekend for us and the 20 public to take a good look at it and be able to dive into it. Um, I'm very 21 appreciative of the effort that our delegates made as far as the deep dive 22 that they did do, and I personally, I cannot put a deferral on the floor 23 myself as Chair at this point in time, but I would be in support of a 24 deferral. The one question I just wanted to clarify is the length of the 25 deferral. There was some question at the break about, uh, the timing 26 around October Committee and I just wanted to check in. I specifically 27 understand it's in regard to the, um, trip to Japan, and just to clarify with 28 the Mayor as to whether Councillor, Councillor, Nissan and the Mayor 29 will in fact be, from what I understand,, available for October Committee, 30 just a way for Council. So it could be a deferral for one month to October 31 committee to still be discussed at that time. Is that correct?

1	MEED WARD:	Yes.
2	STOLTE:	Okay, that is correct. Okay. Councillor Kearns, you have questions or
3	11:41	comments.
4	KEARNS:	I just want to, I just want to confirm through the Chair, do we have
5		something else on the floor at this moment?
6	YEW:	Yes.
7	KEARNS:	Okay, so I will speak after that.
8	STOLTE:	Sorry, clarity, something else on the floor in regards to a deferral? No, we
9		have the main motion.
10	YEW:	Uh, the recommendation from the report, recommendation from the
11		report. Yeah, I don't have the recommendation from the report typed up to
12		show on the screen.
13	KEARNS:	Okay, so I wanna table a deferral.
14	YEW:	So it takes precedence.
15	STOLTE:	Okay. So, Councillor Kearns, you're moving forward with a motion to
16		defer this until-, would you need a minute or two to get the wording?
17	KEARNS:	No. May I have, may I have the Clerks put it on the screen, please.
18	STOLTE:	Okay.
19	KEARNS:	Uh, they're gonna move P2P and then put the rest on onto October. Okay.
20		So in, in, uh, in collaboration with Staff, this is, uh, language that they
21	11:42	have drafted and, and circulated to me. Uh, so I would like to put the
22		consideration of the balance to October. I told you there are three, three
23		conversations happening here, one with the public, one with Council, and
24		one with Staff. I'd like to close those loops, and I would like to direct
25		Staff to bring forward a Procedure By-law amendment to September 17th
26		Council, uh, that allows Pipeline to Permit Committee to effectively
27		proceed. So, uh, this is holding the balance until October to be
28		appropriately reviewed and then to allow the issue that we're trying to
29		solve, which is to make sure that Pipeline to Permit can continue
30		appropriately. Uh, that solves that problem so those are the two that I'd
31		like to table. You can separate them if anybody is, is so inclined to do.

1	STOLTE:	Okay. Thank you. So this is now taking precedence on the floor. I'd like
2		to ask a quick question seeing no other hands on the board. I'm not sure if
3	11:43	this is a question to our City Clerk or to our City Solicitor, but the second
4		piece of this to direct Staff to bring forward a Procedure By-law
5		amendment for the September 17th Council meeting to include Pipeline to
6		Permit Committee, would that result in a cancellation of the September
7		12th Pipeline to Permit Committee that's scheduled for this week or would
8		that be able to go forward?
9	HURLEY:	Uh, Chair no. That meeting would go forward.
10	STOLTE:	Okay, great. Okay, so we have a deferral on the floor. Do you have any
11		questions to this? Councillor Bentivegna.
12	BEN:	Thank you, chair and thank you, Councillor for bringing this forward. I'd
13		like to have these two, uh, separated as a vote.
14	STOLTE:	Okay. Thank you. We'll separate them out. Mayor Meed Ward, please
15		go ahead.
16	MEED WARD:	Uh, thank you. I'd like to amend the deferral to the September Council
17		meeting. Change the date of it.
18	STOLTE:	Uh, the motion on the floor, Councillor Kearns, are you amenable to that?
19	11:44	
20	KEARNS:	No, it would be a different one.
21	MEED WARD:	Sorry I'm amending, I'm formally putting an amendment to defer to
22		change this amendment to the September meeting so we would have to
23		vote on that first.
24	STOLTE:	We're going two out now, okay. Councillor Nisan, we're two
25		amendments, two motions out now. Are you clear on-, is this a question
26		or a comment on, right now, we're looking at a deferral to the September
27		meeting or September Council.
28	NISAN:	Yeah. Thank you. Thank you, Vice Chair, and thank you for chairing
29		today as well. Uh, oh, I put my hand up to say that I would support a
30		deferral to, uh, September. Then we go from there, uh, and, and consider
31		where we're at at that point. Um, I, so I would support this amendment.

1	11:45	I'm not sure if we can amend the deferral. So I was just checking the
2		Procedure By-law as we were going through here so if, uh, the Clerk could
3		confirm that would be great. Thank you.
4	YEW:	Through the Chair, uh, motions to postpone definitely are motions to defer
5		are amendable as to date and or time, and that's on page 35 of the
6		Procedure By law, the current Procedure By-law, if you're interested.
7	NISAN:	Thank you very much.
8	STOLTE:	Thank you. Councillor Kearns, questions or comments to the second
9		deferral that's on the floor now to September 17th Council meeting?
10	KEARNS:	Chair, I just want to, um, make anyone aware that's interested that I won't
11		be voting for this, and I will be bringing back the October date.
12	STOLTE:	Councillor Bentivegna.
13	BENTIVEGNA:	Thank you, chair. I will be, uh, supporting this, uh, this motion and, and
14		again I just wanna bring to light, it is a living document. We've talked
15	11:46	about it. Procedural by-laws change all the time. We change them. We
16		can do what is necessary to get done as is stated, uh, in this motion, and
17		continue to change what we wanna change moving forward. Uh, we have
18		a Councillor who has, uh, mentioned three pages. I mean, it's great, so I
19		think even if we got those sent to us, we can review them, and give, you
20		know, feedback based on that and we're still moving forward. I, I think
21		delaying, delaying of, you know, again as the mayor mentioned,
22		you know, we're done with that, you know, let's, let's move forward. Let's
23		make the best decisions we can make at the moment, and get this done.
24	11:47	Thank you.
25	STOLTE:	Thank you, Councillor. Councillor Sharman.
26	SHARMAN:	Thank you very much. Uh, just start off by saying that I in no way was
27		referring to the Clerk and the work that's been done when I said this was
28		incomplete Staff work. What I was referring to was a process problem.
29		The, the process problem, uh, is that, that we have a better example in the
30		way we do budgets when we ask Council members to bring forward
31		changes, potential changes, to what is in front of us and then Staff

1		codifying that and putting that on the table so that we have that in advance
2		of the meeting. I do not believe, uh, I believe that would have been
3		helpful. So when I say this is incomplete Staff work, I was referring to the
4		fact that we haven't got that input because we have not had time to look at
5		the draft in the way that would allow us then to bring forward a
6		discussion, uh, table to allow us to have a full a full, um, uh, a properly
7		informed dialogue. I don't know anything about 30-, thr-, 3 pages, 10
8	11:48	pages, whatever. I don't know anything about any of them to going to a
9		meeting, um, straight out and having it in front of everybody when we're
10		all sitting there going gasping, that makes no sense to me at all. Um, that
11		leads me back to the, the discussion that I was having about could we do it
12		partly this September Council and partly in October. Um, and, and that is
13		still where my head is at is because I think we have a procedural process,
14		but it's a process problem that would be really helpful to resolve because
15		I'd like to know what everybody's thinking so that when we have a
16		conversation, I can deal with it rather than just, just have it on a
17		randomized basis. I can't-, I, I r-, I, I will vote for the, uh, the, the original
18		version, but not with the September 17th in there. So I'm, I'm okay with
19		the original deferral. Uh, I'm, I'm sensitive to, to everybody's need to get
20		ahead, but frankly, I've heard the lawyer also say it's okay to give us some
21		of it now and we'll, as an amendment, and we can do the rest in October
22	11:49	and we'll be okay. We're not gonna lose any momentum. My belief is we
23		can do a better job. So I, I will not support the amendment to the deferral,
24		I will support the original deferral. Thank you.
25	STOLTE:	Thank you, Councillor. Okay, I'm seeing no more questions or comments
26		on the board in regards to what's on the floor right now, which is to defer
27		the consideration of CL-01-24 to the September 17th, 2024 Council
28		meeting. I just wanna double check with the Clerk, is there any difference
29		in-, we've been asked to separate these two out. Do we need to do with
30		the amendment first before a deferral?
31	YEW:	Yes.

1	STOLTE:	Okay.
2	YEW:	What we have brought forward, so we're going to deal with the deferral to
3		the September Council meeting. That's what we're gonna do, right?
4	STOLTE:	But what's on the board here about directing Staff by the procedure?
5	YEW:	We're not gonna do that just yet.
6	STOLTE:	Okay, that's second. Okay. All right. Okay, so the first vote we're going
7		to take, seeing no further comments or questions-, oh, Councillor
8		Bentivegna.
9	BENTIVEGNA:	Yeah, just a quick comment. We don't need to separate this particular
10		motion in terms of the vote, it was the original one I wanted separated.
11	11:50	
12	STOLTE:	Okay. Okay.
13	YEW:	So we're dealing with the Mayor's amendment.
14	STOLTE:	Yes.
15	YEW:	Yes.
16	STOLTE:	So first we're going to vote on deferring the consideration of CL-01-24 to

18		carries. Okay. Thank you for the clarity. So now we're going to vote on
19		directing Staff to bring forward a Procedure By-law amendment for the

22	MEED WARD:	I'm just wondering if that's necessary since we've deferred the entire by-
23		law to Council and we'll discuss the whole thing then. I guess that would
24		be a question of Staff. It just would kind of be captured in that work, I
25	11:51	think, at Council.
26	STOLTE:	Sorry, Councillor Kearns.
27	KEARNS:	That was a question for Staff, Chair, sorry. I'm offering a withdraw.
28	STOLTE:	Yeah, I was getting an indication for Counselor Kearns and she's willing
29		to withdraw that. Okay, so I gather that has dealt with this item, then that
30		it has been voted on successfully to defer to the September 17th Council
31		meeting. Okay, it's 5 minutes to 12. Clearly, we're going to still have a

1		fairly full afternoon. Um, I d-, wanna. Oh, okay. Blake, you have some
2		comments or questions.
3	HURLEY:	Uh, thank you, Chair. Uh, just, just so we have some clarity around the
4	HORLI.	table and, and we can certainly work offline with this as well is that we,
		•
5	11.50	we will need to establish a deadline for getting those comments in so we
6	11:52	can turn those around, get them back to members of Council so we have

20		on that item. Thank you.
