

THE CORPORATION OF THE CITY OF BURLINGTON

BY-LAW NUMBER 45-2025

A By-law to amend By-law 70-2024, being a by-law to establish and impose certain 2025 rates and fess for services, activities or the use of property
(F-30-24)

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001*, authorize the City of Burlington to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the City of Burlington; and

WHEREAS Section 391(1) of the *Municipal Act, 2001*, as amended, authorizes The Corporation of The City of Burlington to impose fees and charges on persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control; and

WHEREAS on November 19, 2024 Council approved report F-30-24 and passed By-law 70-2024 adopting 2025 Rates and Fees; and

WHEREAS Council of the City of Burlington has deemed it necessary to amend certain Transit and Specialized Transit rates and fees in By-law 70-2024 to reduce the Youth Loyalty Program from 40 taps to 20 taps effective September 1, 2025 to June 30, 2026;

NOW THEREFORE the Council of the Corporation of the City of Burlington hereby enacts as follows:

1. The section titled "Conventional & Specialized Transit", page 23 of Schedule A of By-law 70-2024, is hereby deleted and replaced in its entirety with "Conventional & Specialized Transit" page 23, attached to this by-law as Appendix A.
2. That in all other respects By-law 70-2024, as amended, be and is hereby confirmed.
3. That this by-law comes into force on September 1, 2025
