

THE CORPORATION OF THE CITY OF BURLINGTON

BY-LAW NUMBER XX-2025

A By-law to amend By-law 70-2024, being a by-law to establish and impose certain 2025 rates and fess for services, activities or the use of property (DGM-71-25)

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001*, authorize the City of Burlington to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the City of Burlington; and

WHEREAS Section 391(1) of the *Municipal Act, 2001*, as amended, authorizes the The Corporation of The City of Burlington to impose fees and charges on persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control; and

WHEREAS on November 19, 2024 Council approved report F-30-24 and passed By-law 70-2024 adopting 2025 Rates and Fees; and

WHEREAS Council of the City of Burlington has deemed it necessary to amend certain rates and fees in By-law 70-2024; and

WHEREAS it is desirable to amend By-law Compliance Rates to update fees related to short-term rentals, licensing appeal committee, sign storage by-law and to correct labelling errors;

NOW THEREFORE the Council of the Corporation of the City of Burlington hereby enacts as follows:

1. The fee titled "Sign Storage (By-law 74-2005): \$10.00 per day of storage after the first five (5) days of storage", located in the section titled "Sign permits/enforcement" on page 18 of 84 in Schedule A of By-law 70-2024, as amended, be deleted in its entirety.
2. The title "Adult Entertainment (By-law 74-2005)", located on page 19 of 84 in Schedule A of By-law 70-2024, as amended, be amended by deleting the number "74-2005" located after the words "Adult Entertainment By-law" and replaced with "01-2008".
3. The title "Licensing Committee Hearing Fee" located in the section titled "Adult Entertainment (By-law 74-2005)" and subsection "Other Fees", on page 19 of 84 in

Schedule A of By-law 70-2024, as amended, be deleted in its entirety and replaced with “Appeal Committee Fee”.

4. The “2025 Base Rate” of \$353.74 located in the section “Adult Entertainment (By-law 74-2005)” and subsection “Other Fees” titled “Licensing Committee Hearing Fee” on page 19 of 84 in Schedule A of By-law 70-2024, as amended, be deleted in its entirety and replaced with a fee of \$445.
5. The title “Licensing Committee Hearing Fee” located in the section “Public Vehicles (By-law 20-2009)” and subsection “Other Fees”, on page 19 of 84 in Schedule A of By-law 70-2024, as amended, be deleted in its entirety and replaced with “Appeal Committee Fee”.
6. The “2025 Base Rate” of \$460.02 located in the section “Public Vehicles (By-law 20-2009)”, subsection “Other Fees” titled “Licensing Committee Hearing Fee”, on page 19 of 84 in Schedule A of By-law 70-2024, as amended, be deleted in its entirety and replaced with a fee of \$445.
7. The title “Licensing Committee Hearing Fee” located in the section “Businesses (By-law 42-2008)” and subsection “Other Fees”, on page 21 of 84 in Schedule A of By-law 70-2024, as amended, be deleted in its entirety and replaced with “Appeal Committee Fee”.
8. The “2025 Base Rate” of \$429.00 located in the section “Businesses (By-law 42-2008)”, and subsection “Other Fees” titled “Licensing Committee Hearing Fee”, located on page 21 of 84 in Schedule A of By-law 70-2024, as amended, be deleted in its entirety and replaced with a fee of \$445.
9. That a new section titled “Short-Term Rental (By-law 01-2025)” be inserted after the section “Liquor Sales Licence Application”, on page 22 of 84 in Schedule A of By-law 70-2024, as amended, with the following fees added:
