City of Burlington By-law 06-2026

A by-law to amend By-law 86-2007, as amended, being a by-law for the regulation of traffic.
Delegated Authority

Whereas pursuant to subsection 27 (1) of the Municipal Act, 2001, S.O. 2001, c. 25, a municipality may pass by-laws in respect of a highway only if it has jurisdiction over the highway;

Now therefore the Council of the Corporation of the City of Burlington hereby enacts as follows;

1. Schedule 1 of By-law 86-2007, as amended, (Section 12 (1) – Through Highways – Stop) is amended by adding the following line items in alphabetical order:

Cardinal Avenue	West limit	West limit of Eagle Drive
Eagle Drive	North limit of Shoreview Road	South limit of Townsend Avenue (north intersection)
Falcon Boulevard	South limit of Plains Road East	North limit of Townsend Avenue (north intersection)
Partridge Drive	North limit of Cardinal Avenue	South limit of Townsend Avenue

2. Schedule 2 of By-law 86-2007, as amended, (Section 12 (2) – Intersections – Stop Signs) is amended by removing the following line items in alphabetical order:

Cardinal Avenue and Eagle Drive	Eastbound and westbound	Cardinal Avenue
Eagle Drive and Townsend Avenue	Northbound and southbound	Eagle Drive
Falcon Boulevard and Townsend Avenue	Southbound and northbound	Falcon Boulevard
Falcon Boulevard and Townsend Avenue East	Northbound	Falcon Boulevard

Townsend Avenue East and Eagle Drive	Eastbound and westbound	Townsend Avenue East
Townsend Avenue East and Falcon Boulevard	Eastbound and westbound	Townsend Avenue East
Townsend Avenue East and Shadeland Avenue	Eastbound and westbound	Townsend Avenue

3. Schedule 2 of By-law 86-2007, as amended, (Section 12 (2) – Intersections – Stop Signs) is amended by adding the following line items in alphabetical order:

Eagle Drive and Townsend Avenue (north intersection)	Northbound and southbound	Eagle Drive
Falcon Boulevard and Townsend Avenue (north intersection)	Eastbound and southbound	Falcon Boulevard
Townsend Avenue and Eagle Drive (north intersection)	Eastbound	Townsend Avenue (north intersection)
Townsend Avenue and Falcon Boulevard (north intersection)	Westbound	Townsend Avenue (north intersection)
Townsend Avenue and Falcon Boulevard (south intersection)	Eastbound	Townsend Avenue (south intersection)

4. Schedule 4 of By-law 86-2007, as amended, (Section 13 (2) – Intersections – Yield Signs) is amended by deleting the following line items in alphabetical order:

Finch Avenue and Falcon Boulevard	Eastbound	Finch Avenue
Lark Avenue and Falcon Boulevard	Eastbound	Lark Avenue
Partridge Drive and Cardinal Avenue	Southbound	Partridge Drive

5. That in all other respects By-law 86-2007, as amended, be and is hereby confirmed.
6. That this by-law comes into force the day it is passed.
